

ORDINANCE OF JERSEY CITY, N.J.

COUNCIL AS A WHOLE
offered and moved adoption of the following ordinance:

CITY ORDINANCE 19-124

TITLE: AN ORDINANCE SUPPLEMENTING CHAPTER 332(VEHICLES AND TRAFFIC) ARTICLE VII (METERED PARKING) SECTION 332-48 (DESIGNATION OF PARKING SPACES) AMENDING SECTIONS 332-48 (DESIGNATION OF PARKING SPACES) AND 332-58.1.1 (PARKING RESTRICTIONS IN MUNICIPAL LOTS) OF THE JERSEY CITY CODE

THE MUNICIPAL COUNCIL OF THE CITY OF JERSEY CITY DOES ORDAIN:

1. Chapter 332 (Vehicles and Traffic) Article VII (Metered Parking) of the Jersey City Code is hereby supplemented as follows:

Section 332 – 48 Designation of parking spaces.

A. No Change

B. Off-Street Parking Lot Meter Zones. Parking or standing a vehicle in a parking meter space in the off-street parking lot meter zones described below shall be lawful during the hours of 9:00 a.m. to 6:00 p.m., Monday through Saturday, excepting official State holidays, and only upon the deposit of such amount as is indicated for each specified period of time

§ 332-58.1. - Parking restrictions in municipal lots.

A. No person shall park a vehicle in a municipal lot without a valid parking permit.

B. There may be two (2) types of parking permits allowed in a municipal lot:

1. [NP] - Nighttime parking only (7:00 p.m.—7:00 a.m.);

2. [24/7] - All day/all night parking (24 hours).

(a.) No new permits will be issued for Lot 9. Permits given out prior to this ordinance will be able to continue parking. Those permit holders may continue to renew their permits, however, no new permits may be issued. When an existing permit is not renewed, the space where the permit holder used to park will become a metered space open to the public and no permit will be issued to replace it.

3. The City Clerk and the Corporation Counsel may change any chapter numbers, article numbers and section numbers if codification of this ordinance reveals a conflict between those numbers and the existing code, in order to avoid confusion and possible accidental repealers of existing provisions.

4. This ordinance shall be a part of the Jersey City Code as though codified and incorporated in the official copies of the Jersey City Code.


