

# Ordinance of the City of Jersey City, N.J.

AN ORDINANCE SUPPLEMENTING CHAPTER 332 (VEHICLES AND TRAFFIC) ARTICLE III (PARKING, STANDING AND STOPPING) AMENDING SECTIONS 332-22 (NO PARKING ANY TIME); 332-23 (NO STOPPING OR STANDING); SECTION 332-31 (PARKING RESTRICTIONS FOR STREET CLEANING PURPOSES) AND 332-48 (DESIGNATION OF PARKING SPACES) TO ACCOMMODATE PROTECTED BICYCLE LANES ON BERGEN AVENUE.

COUNCIL AS A WHOLE offered and moved adoption of the following ordinance:

1. Chapter 332 (Vehicles and Traffic) Article III (No stopping or standing) of the Jersey City Code is hereby supplemented as follows:

**Section 332-22**      **Parking prohibited at all times**  
No person shall park a vehicle on any of the streets or parts thereof described.

**Section 332-23**      **No Stopping or Standing**  
No person shall stop or stand a vehicle upon any of the streets or parts thereof listed below.

**Section 332-31                      Parking restrictions for street cleaning purposes.**

No person shall park a vehicle upon any of the streets or sides of the streets either in whole or in part, during the hours of the days listed below.

**Section 332-48                      Designation of Parking Spaces**

On-street Parking Meter Zones. Parking or standing a vehicle in a parking meter space in the on-street parking meter zones described below shall be lawful during the hours of 9:00 a.m. to 6:00 p.m., Monday through Saturday, excepting official State holidays, and only upon the deposit of such amount as is indicated for each specified period of time.

2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
3. This ordinance shall be a part of the Jersey City Code as though codified and incorporated in the official copies of the Jersey City Code.
4. The City Clerk and the Corporation Counsel be and they are hereby authorized and directed to change any chapter numbers, article numbers and section numbers in the event that the codification of this ordinance reveals that there is a conflict between those numbers and the existing code, in order to avoid confusion and possible accidental repealers of existing provisions.
