offered and moved adoption of the following ordinance:

CITY ORDINANCE 19-109

TITLE:

**ORDINANCE AMENDING CHAPTER 332 (VEHICLES & TRAFFIC),  
ARTICLE III (PARKING, STANDING AND STOPPING), OF THE  
JERSEY CITY MUNICIPAL CODE**

**THE MUNICIPAL COUNCIL OF THE CITY OF JERSEY CITY HEREBY ORDAINS:**

**WHEREAS**, municipalities can and have regulated parking; and

**WHEREAS**, many complaints have been received about parking in front of Duane Reade obstructing traffic and pedestrian safety; and

**WHEREAS**, commercial trucks making deliveries to stores at the intersection of Newark and Grove continue to stop traffic even after violations have been issued; and,

**WHEREAS**, a loading and unloading zone is being proposed on Christopher Columbus Drive to provide an alternative for deliveries.

**NOW, THEREFORE, BE IT ORDAINED** by the Municipal Council of the City of Jersey City that:

**THE FOLLOWING AMENDMENTS TO CHAPTER 332 (VEHICLES & TRAFFIC),  
ARTICLE III (PARKING, STANDING AND STOPPING), ARE HEREBY ADOPTED:**

The section of Newark from Grove to Columbus Drive shall be a tow-away zone and have signs designating the same.

- B. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
- C. This ordinance shall be a part of the Jersey City Code as though codified and fully set forth therein. The City shall have this ordinance codified and incorporated in the official copies of the Jersey City Code.
- D. This ordinance shall take effect immediately
- E. The City Clerk and the Corporation Counsel be and they are hereby authorized and directed to change any chapter numbers, article numbers and section numbers in the event that the codification of this ordinance reveals that there is a conflict between those numbers and the existing code, in order to avoid confusion and possible accidental repeal of existing provisions.


