**AN ORDINANCE SUPPLEMENTING CHAPTER 332 (VEHICLES AND TRAFFIC) ARTICLE IX (PARKING FOR THE DISABLED) OF THE JERSEY CITY CODE DESIGNATING A RESERVED PARKING SPACE AT VARIOUS LOCATIONS THROUGHOUT THE CITY.**

**COUNCIL AS A WHOLE offered and moved adoption of the following ordinance:**

1. Chapter 332 (Vehicles and Traffic) Article III (Parking, Standing and Stopping) and Article IX (Parking for the Disabled) of the Jersey City Code is hereby supplemented as follows:

Section 332-29 Disabled Parking Manual  
Section 332-69 Restricted parking zones in front or near residences of disabled drivers

## PARKING FOR THE DISABLED

Restricted parking spaces (measuring approximately 22 feet in length) in front of residential buildings for use by persons who have been issued special vehicle identification cards by the Division of Motor Vehicles and handicapped parking permits issued by the Traffic Division.

**Purpose**

The purpose of this ordinance is to designate reserved parking spaces at various locations throughout the City. All applicants have submitted applications for a reserved parking space and have been reviewed and recommended for approval by the Committee at the meeting held on February 18, 2021. Of the applications 65 reviewed, 14 new spaces were approved, 3 existing spaces had names changed, 7 people moved, 1 generic space was approved, 37 were denied, and 3 are pending more information. Each reserved parking space will have a two year mandatory renewal.
