AN ORDINANCE OF THE CITY OF JERSEY CITY SUPPLEMENTING CHAPTER 131 (CONSTRUCTION CODES, UNIFORM) ADDING ARTICLE II REQUIRING GENDER NEUTRAL BATHROOM SIGNAGE FOR SINGLE-USER RESTROOMS.

COUNCIL AS A WHOLE offered and moved adoption of the following ordinance:

AN ORDINANCE OF THE CITY OF JERSEY CITY SUPPLEMENTING CHAPTER 131 (CONSTRUCTION CODES, UNIFORM) ADDING ARTICLE II REQUIRING GENDER NEUTRAL BATHROOM SIGNAGE FOR SINGLE-USER RESTROOMS.

THE MUNICIPAL COUNCIL OF THE CITY OF JERSEY CITY DOES ORDAIN THAT:
WHEREAS, Jersey City is recognized as one of the most diverse cities in the U.S.; and
WHEREAS, Jersey City has been a home to the LGBTQ+ community and has prominent community leaders that make the city better every day.; and
WHEREAS, Jersey City has been a leader in LGBTQ+ policy including using executive orders to create gender-neutral bathrooms in municipal buildings., and
WHEREAS, restricting access to single-occupancy restrooms by gender creates problems of safety, and equity; and
WHEREAS, we must focus on equalizing access to all public facilities; and
WHEREAS, Jersey City residents of all genders should feel welcomed in all public accommodations.
NOW THEREFORE, be it ordained by the Municipal Council of the Jersey of Jersey City that:

GENDER-NEUTRAL SIGNAGE FOR SINGLE-USER RESTROOMS

§ -131-14 Definitions.
(A) GENDER NEUTRAL SIGNAGE mean a sign that indicates a restroom without preference to a specific gender.
(B) SINGLE-USER RESTROOM means a lockable restroom available for an individual for use with or without assistance.


§-131-15 SIGNAGE REQUIRED.
(A) Where single-use restroom facilities are permitted by the law, such facilities shall have gender-neutral signage no later than the sixtieth (60) day following the effective date of this ordinance. [1] New facilities shall comply upon opening for public use.
(B) Gender-neutral signage may include any one of the following:

- B. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
- C. This ordinance shall be part of the Jersey City Code as though codified and fully set forth therein. The City Clerk shall have this ordinance codified and incorporated in the official copies of the Jersey City Code.
- D. This ordinance shall take effect at the time and in the manner provided by law.
- E. The City Clerk and Corporation Counsel be and they are hereby authorized and directed to change any chapter numbers, article numbers and section numbers in the event that the codification of this ordinance reveals

that there is a conflict between those numbers and the existing code, in order to avoid confusion and possible accidental repeal of existing provisions.

NOTE: All material is new; therefore underlining has been omitted. For purposes of advertising only, new matter is indicated by bold face and repealed matter by italic.

[1] (1)In accordance to National Standard Plumbing Code, in occupancies serving 15 or fewer people, one toilet facility, designed for use by no more than one person at a time, shall be permitted for use by both sexes.
(2)In business occupancies with a total floor area of 1500 square feet or less, one toilet facility, designed for use by no more than one person at a time, shall satisfy the requirements for serving customers and employees of both sexes.
(3)In mercantile occupancies with a net occupiable floor area of 1500 square feet or less that is accessible to customers, one toilet facility designed for use by no more than one person at a time shall satisfy the requirements for serving customers and employees of both sexes.
