AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 23 (COURT, MUNICIPAL) OF THE JERSEY CITY MUNICIPAL CODE TO ADD ONE (1) ADDITIONAL FULL TIME JUDGE TO THE MUNICIPAL COURT.

COUNCIL AS A WHOLE offered and moved adoption of the following ordinance:

THE MUNICIPAL COUNCIL OF JERSEY CITY DOES ORDAIN:

A. The following amendments to CHAPTER 23 (COURT, MUNICIPAL), are hereby adopted:

(Note: All new material is underlined; words ~~struck through~~ are omitted.)

"§ 23-2. - Number of Judges; terms.

A. The Municipal Court of Jersey City shall consist of ~~eleven~~ twelve Judges. ~~Six~~ Seven of the Judges shall be full-time Judges, and five of the Judges shall be part-time Judges. One of the full-time Judges shall be designated the Chief Judge in accordance with § 23-8."


B. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

C. The City Clerk and the Corporation Counsel may change any chapter numbers, article numbers and section numbers if codification of this ordinance reveals a conflict between those numbers and the existing code, in order to avoid confusion and possible repeals of existing provisions.


D. This ordinance shall take effect at the time and in the manner provided by law.

E. This ordinance shall be a part of the Jersey City Code as though codified and incorporated in the official copies of the Jersey City Code.
