AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 160 (FEE SCHEDULE ESTABLISHED), SUBSECTION CHAPTER 332 (VEHICLES AND TRAFFIC) AMENDING NON-RESIDENTIAL PARKING PERMIT FEES.

COUNCIL AS A WHOLE offered and moved adoption of the following ordinance:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JERSEY CITY AS FOLLOWS:

Chapter 160

Subsection Chapter 332 Vehicles and Traffic

(1) – (9) No Change.

(10) On street parking permit fees. The fee for a residential V permit or temporary residential parking permit shall be as follows:

a. Residential parking permit or new resident temporary parking permit:

(i) \$20 per year for the first vehicle per household within the appropriate zone, then, for each vehicle after the first, the price for an annual permit shall increase incrementally by \$10;

(ii) For any individual 65 years of age or older who submits proper proof of age and residency in accordance with this chapter, there shall be no charge for the first two permits, then fees pursuant to Subsection (i) and (iv) shall apply for each vehicle after the first two.

b. Non-residential parking permit: \$500.00 per year;

Non-resident City government employees: \$40.00 per year; and

Non-resident teacher, faculty and staff: \$40.00 per year with proof of employment at a Jersey City PreK-12 school.

c. Temporary resident parking permit (90-day): \$125.00;

Temporary work permit (90-day): \$125.00 and not more than 90 days; and

Temporary residential permit (14-day): \$20.00.

d. Home healthcare permit (90-day): \$50.00.

e. Contractor parking permit (one- and two-family residences):

(i) Six-month permit: \$175.00; and

(ii) Daily permit: \$15.00 a day.

f. Visitors parking permit: Daily: \$10.00 for each permit for up to five permits; provided, however, that residents of the Jersey City Housing Authority may obtain up to five permits without fee.

g. Transfer permit: \$15.00.

h. Deed restricted low/moderate income residents or R-2 residents: \$0.00.

i. Zone 16-2: \$50.00 per six-month period for each vehicle registered to a person currently working for an employer located within parking Permit Zone 16.

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF

Chapter 160

Subsection Chapter 332 Vehicles and Traffic

(1) – (9) No Change.

(10) On street parking permit fees. The fee for a residential V permit or temporary residential parking permit shall be as follows:

a. Residential parking permit or new resident temporary parking permit:

(i) \$20 per year for the first vehicle per household within the appropriate zone, then, for each vehicle after the first, the price for an annual permit shall increase incrementally by \$10;

(ii) For any individual 65 years of age or older who submits proper proof of age and residency in accordance with this chapter, there shall be no charge for the first two permits, then fees pursuant to Subsection (i) and (iv) shall apply for each vehicle after the first two.

b. Non-residential parking permit: \$500.00 per year;

Non-resident City government employees: ~~\$200.00~~ \$40.00 per year;

Non-resident teacher, ~~faculty and staff~~: \$40.00 per year with proof of employment at a Jersey City ~~pre~~K-12 school;

c. Temporary resident parking permit (90-day): \$125.00;

Temporary work permit (90-day): \$125.00 and not more than 90 days;

Temporary residential permit (14-day): \$20.00;

d. Home healthcare permit (90-day): \$50.00;

e. Contractor parking permit (one- and two-family residences):

(i) Six-month permit: \$175.00; and

(ii) Daily permit: \$15.00 a day;

f. Visitors parking permit: Daily: \$10.00 for each permit for up to five permits; provided, however, that residents of the Jersey City Housing Authority may obtain up to five permits without fee;

g. Transfer permit: \$15.00;

h. Deed restricted low/moderate income residents or R-2 residents: \$0.00.

i. Zone 16-2: \$50.00 per six-month period for each vehicle registered to a person currently working for an employer located within parking Permit Zone 16.
