AN ORDINANCE OF THE MUNICIPAL COUNCIL OF THE CITY OF JERSEY CITY ADOPTING AMENDMENTS TO THE NEWPORT AND HARSIMUS COVE STATION REDEVELOPMENT PLANS.

COUNCIL AS A WHOLE offered and moved adoption of the following ordinance:

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 ets eq. Permits municipalities to adopt and amend regulations within areas declared to be "in need of redevelopment" and "in need of rehabilitation"; and

WHEREAS, the Municipal Council of the City of Jersey City adopted a redevelopment plan for the Newport Redevelopment Plan Area in February 1985; and

WHEREAS, the Newport Redevelopment Plan has been amended periodically since its adoption, the latest being on June 27. 2012 by Ordinance 12-084; and

WHEREAS, the Municipal Council of the City of Jersey City adopted a redevelopment plan for the Harsimus Cove Station Redevelopment Plan Area in 1983; and

WHEREAS, the Harsimus Cove Station Redevelopment Plan has been amended periodically since its adoption, the latest being on April 13, 2022 by Ordinance 22-024; and

WHEREAS, the Municipal Council of the City of Jersey City wishes to assure continued development and redevelopment of the Newport and Harsimus Cove Station Redevelopment Areas that is both appropriate for Jersey City's changing needs and consistent with actual conditions; and

WHEREAS, this ordinance modifies the Newport and Harsimus Cove Station Redevelopment Plans by realigning the Southern boundary of the Newport Redevelopment Plan and the northern boundary of the Harsimus Cove Station Redevelopment Plan; and

WHEREAS, this ordinance further modifies the Newport Redevelopment Plan by revising its permitted uses, parking standards and other standards; and

WHEREAS, on September 7, 2023 the Municipal Council of the City Jersey City referred amendments to the Newport and Harsimus Cove Station Redevelopment Plans to the Jersey City Planning Board to seek the Board's report and recommendations relative to the amendment, including consistency review with the City's Master Plan by Resolution 23-676; and

WHEREAS, on November 14, 2023, the Jersey City Planning Board reviewed, discussed, amended and recommended adoption of the amendments attached hereto; and

WHEREAS, floor amendments are included intending to clarify language in the Newport Redevelopment Plan and exclude tourism activities associated with helistop and vertiports uses; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JERSEY CITY AS FOLLOWS:

 The amendments to the Newport Redevelopment and Harsimus Cove Station Redevelopment Plan, attached hereto, be and hereby are adopted.

BE IT FURTHER ORDAINED THAT:

- A. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.
- B. This ordinance shall be a part of the Jersey City Code as though codified and set forth fully herein. The City Clerk shall have this ordinance codified and incorporated in the official copies of the Jersey City Code. The Division of City Planning Staff shall have this ordinance codified and incorporated in the official copies of the Jersey City Zoning Map.
- C. This ordinance shall take effect at the time and in the manner as provided by law.
- D. The City Clerk and the Corporation Council be and they are hereby authorized and directed to change any chapter numbers, article numbers and section numbers in the event that the codification of this ordinance reveals that there is a conflict between those numbers and the existing code, in order to avoid confusion and possible repealers of existing provisions.
- E. The City Planning Division is hereby directed to give notice at least ten (10) days prior to the hearing on the adoption of this Ordinance to the Hudson County Planning Board, the Clerk of the City of Hoboken, and to all other persons entitled thereto pursuant to N.J.S.A. 40:55D-15 and N.J.S.A. 40:55D-63 (if required). Upon the adoption of this Ordinance after public hearing thereon, the City Clerk is directed to publish notice of the passage thereof and to file a copy of the Ordinance as finally adopted as required by N.J.S.A. 40:55D-16. The clerk shall also forthwith transmit a copy of this Ordinance after final passage to the Municipal Tax Assessor as required by N.J.S.A. 40:49-2.1.

The purpose of the Amendments is to adjust the boundaries of the Harsimus Cove Station and Newport Redevelopment Plans along with updating permitted uses and standards of the Newport Redevelopment Plan.
