**AN ORDINANCE OF THE CITY OF JERSEY CITY DESIGNATING THE JERSEY CITY MUNICIPAL OFFICES LOCATED AT 394 CENTRAL AVE, JERSEY CITY, NJ 07307 AS THE "MICHAEL YUN MUNICIPAL SERVICES CENTER".**

**COUNCIL AS A WHOLE offered and moved adoption of the following ordinance:**

**Whereas, the City of Jersey City wishes to honor and commemorate the late Ward D Councilman Michael Yun for his dedicated service to the community; and**

**Whereas, Michael Yun, a Jersey City resident, local business owner, and Councilman, was an integral part of Jersey City since moving to the Heights in 1981; and**

**Whereas, he faithfully served the Heights as the Ward D Councilman from 2013 until his passing in 2020, tirelessly advocating for residents and championing numerous community initiatives; and**

**Whereas, Michael Yun was a steadfast advocate for small businesses, public safety, the environment, seniors, and quality of life improvements for all Jersey City residents; and**


**Whereas, on April 6, 2020, Michael Yun tragically passed away due to complications related to COVID-19, leaving behind a lasting legacy of public service and dedication; and**


**Whereas, his contribution and sacrifice to Jersey City, and his relentless commitment to the well-being of its residents have a profound and enduring impact on the community; and**

**Whereas, to honor the late Councilman Michaels Yun's memory and his outstanding service, the City of Jersey City wishes to designate the Jersey City Municipal Offices located at 394 Central Avenue, Jersey City, NJ 07307 as the "*Michael Yun Municipal Services Center*."**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JERSEY CITY AS FOLLOWS: the Municipal Offices of Jersey City located at 394 Central Avenue, Jersey City, NJ 07307 shall be designated as the "*Michael Yun Municipal Services Center*" in honor of the late Ward D Councilman Michael Yun.**
