**ORDINANCE NO. 587**

AN ORDINANCE OF THE CITY OF WOODLAKE, COUNTY OF TULARE, STATE OF CALIFORNIA, RESCINDING SECTION 15.04.010 PARAGRAPHS A THROUGH M TITLE 24 CALIFORNIA BUILDING STANDARDS CODES 2010 AND ADDING PARAGRAPHS A THROUGH M TITLE 24 CALIFORNIA BUILDING STANDARDS CODES 2013

THE CITY COUNCIL OF THE CITY OF WOODLAKE DOES ORDAIN AS FOLLOWS:

Section 1: Chapter 15.04, initial paragraph and section 15.04.010 Paragraphs A through M Title 24 California Building Standards Codes 2010 are hereby repealed and Chapter 15.04 Section 15.04.010 Paragraphs A through M Title 24 California Building Standards Codes 2013 are hereby enacted and added to the Woodlake Municipal Code, and shall read as follows:

Section 2: This Ordinance shall become effective thirty days after its final passage and shall be published at least once within fifteen days prior to its effective date in an official newspaper covering the City of Woodlake.


