

BACKGROUND

June 23, 2020 primary election.

The current polling place for precinct 206 is Dominion Place, located 1025 West Grace Street is an apartment complex for persons 62 and older or those persons with disabilities. This population is especially vulnerable to COVID-19. As such, the facility does not wish to allow non-residents into the building for the June 23, 2020 primary election. This Ordinance request is to temporarily relocate the polling place for precinct 206 for the June 23, 2020 election only. The provisions of this Ordinance request shall expire on June 30, 2020.

The VCU 500 Academic Center at 1020 West Grace Street has agreed to serve as the polling place for precinct 206. The proposed new polling place is accessible for persons with disabilities and lies within the existing boundaries of the precinct. Upon adoption of this ordinance, all registered voters (currently 1,724) affected by this change would be notified at least fifteen days before the election on June 23,


