

AN ORDINANCE TO AMEND ORDINANCE NO. 4562  
TO CHANGE THE SIDE OF STREET FOR NO PARKING  
AT ALL TIMES ON CERTAIN STREETS, AND IN PARTICULAR  
TO PROHIBIT PARKING ON THE WEST SIDE EXCEPT FOR  
STREET CLEANING ON MONDAY 1:00 P.M. TO 4:00 P.M.  
AND TO AMEND CHAPTER 10.28.040 , SCHEDULE II, "NO  
PARKING ON CERTAIN HOURS" ON THE EAST SIDE OF WEST  
END PLACE ON MONDAYS 1:00 P.M. TO 4:00 P.M.

BE IT ORDAINED BY CITY COUNCIL OF THE CITY OF ELIZABETH:

**SECTION 1.** That Chapter 10.28.030, Schedule I, No Parking All Times on Certain Streets, of the Code of the City of Elizabeth, is hereby amended to read as follows:

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
WEST END PLACE	WEST	BETWEEN WEST JERSEY STREET AND MURRAY STREET EXCEPT FOR MONDAY 1:00 P.M. TO 4:00 P.M.

**SECTION 2.** That Chapter 10.28.040, Schedule II, No Parking Certain Hours, of the Code of the City of Elizabeth, is hereby amended to read as follows:


**ADD:**

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>HOURS</u>	<u>LOCATION</u>
WEST END PLACE	EAST	MONDAYS FROM 1:00 P.M. TO 4:00 P.M.	BETWEEN WEST JERSEY AND MURRAY STREET


**SECTION 3.** All ordinances or parts of ordinances inconsistent with the provisions of this ordinance be and the same are hereby repealed.

**SECTION 4.** If any portion or clause of this ordinance is declared invalid for any reason whatsoever, same shall not affect the validity or constitutionality of any other part or portion of this ordinance.

**SECTION 5.** The effective date of this ordinance shall be twenty (20) days after its final passage by City Council and approval by the Mayor at the time and in the manner provided by law.
