ORDINANCE NO. 018484

ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.56 (PARKING METERS), SECTION 12.56.030 (PARKING SPACE DESIGNATION-USE) OF THE EL PASO CITY CODE, TO EXEMPT MEMBERS OF CITY BOARDS, COMMISSIONS AND COMMITTEES FROM PARKING METER FEES AT PARKING METERS ALONG EAST MILLS AVENUE WHEN DISPLAYING A CITY-ISSUED PLACARD DURING SCHEDULED CITY BOARD, COMMISSION AND COMMITTEE MEETINGS; THE PENALTY AS PROVIDED IN CHAPTERS 12.84 (VIOLATION - PENALTY) AND 12.85 (PARKING VIOLATIONS BUREAU) OF THE EL PASO CITY CODE.

WHEREAS, the City of El Paso has determined that a need exists to allow members of any city board, commission and committee to park free of charge at city-controlled parking meters along East Mills Avenue during scheduled city board, commission and committee meetings; and

WHEREAS, the City has determined that it can meet this need by issuing to the designated board, commission and committee members a city-issued placard to be displayed on his/her vehicle dashboard while attending scheduled city board, commission and committee meetings; and

WHEREAS, it is therefore necessary to amend the City Code to add the provision relating to this parking meter fee exemption for vehicles owned and operated by members of city boards, commissions and committees in certain situations.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.56 (Parking Meters), Section 12.56.030 (Parking Space Designation-Use) be amended to add Subsection G. as follows:

12.56.030 – Parking Space Designation-Use.

- G. A vehicle displaying a city-issued placard issued to persons appointed to city boards, commissions and committees on the vehicle's dashboard is exempt from the payment of parking fees, including those collected through parking meters, charged by the City. This exemption applies only for parking meters located along East Mills Avenue's north side, between North Campbell Street and North Virginia Street during scheduled City board, commission and committee meetings.

Section 2. Except as herein enumerated, Title 12 (Vehicles and Traffic), Chapter 12.56 (Parking Meters) of the El Paso City Code shall remain in full force and effect.




