

ORDINANCE NO. **018573**

AN ORDINANCE AMENDING TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.52 (PARKING RESTRICTIONS ON CERTAIN STREETS), SECTION 12.52.020 (PARKING PROHIBITED AT ALL TIMES); TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.030 (SCHEDULE III-PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS); AND TITLE 12 (VEHICLES AND TRAFFIC), CHAPTER 12.88 (SCHEDULES), SECTION 12.88.180 (NO STOPPING OR STANDING – TOW AWAY ZONE), PARAGRAPH A (NO PARKING OR STANDING, TOW-AWAY ZONE) OF THE EL PASO CITY CODE, TO PROHIBIT PARKING AROUND THE SAN JACINTO PLAZA, THE PENALTY BEING AS PROVIDED IN SECTION 12.84.010(A) OF THE EL PASO CITY CODE.

WHEREAS, Section 12.88.030 of the El Paso City Code designates the streets on which a person is prohibited from parking a vehicle at any time when prohibited by a sign in accordance with Section 12.52.020 of the El Paso City Code; and

WHEREAS, The amendment of Sections 12.52.020, 12.88.030, and 12.88.180 of the El Paso City Code will prohibit people from parking vehicles around the San Jacinto Plaza thus providing for the safer travel of vehicles and pedestrians and providing citizens with an unobstructed view of the plaza.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF EL PASO:

Section 1. That Title 12 (Vehicles and Traffic), Chapter 12.52 (Parking Restrictions on Certain Streets), Section 12.52.020, is hereby amended in its entirety to read as follows:

When signs are erected or the curb is painted yellow giving notice thereof, no person shall park a vehicle at any time upon any of the streets as described in Schedule III, Section 12.88.030.

Section 2. That Title 12 (Vehicles and Traffic), Chapter 12.88 Schedules, Section 12.88.030 Schedule III – Parking Prohibited at all times on certain streets be amended to **delete** the following language:

"In accordance with Section 12.52.020 and when signs are erected giving notice thereof no person shall at any time park a vehicle upon any of the following described streets or parts of streets:"

and to **replace** the deleted language with the following language:

"In accordance with Section 12.52.020 and when signs are erected or the curb is painted yellow giving notice thereof, no person shall at any time park a vehicle upon any of the following described streets or parts of streets:"

Section 3. That Title 12 (Vehicles and Traffic), Chapter 12.88 Schedules, Section 12.88.030 Schedule III – Parking Prohibited at all times on certain streets, is hereby amended to **add**:

- 380. Mesa Street between Main Drive and Mills Avenue, west side;
- 381. Oregon Street between Main Drive and Mills Avenue, east side;
- 382. Main Drive between Mesa Street and Oregon, south side;
- 383. Mills Avenue between Mesa Street and Oregon, north side;

Section 4. That Title 12 (Vehicles and Traffic), Chapter 12.88 (Schedules), Section 12.88.180 (No stopping or standing – Tow-away zone), Paragraph A (No parking or standing, tow-away zone), is hereby amended to **delete**:

- 34. Mesa Street between Main Drive and Mills Avenue, west side;
- 36. Oregon Street between Main Drive and Mills Avenue, east side;
- 44. Main Drive between Stanton Street and Mesa Street, south side;
- 68. Mills Avenue between Stanton Street and Mesa Street, north side;


Section 5. Except as herein amended, Title 12, Chapter 12.88, and Title 12, Chapter 12.52 of the El Paso City Code shall remain in full force and effect.


