ORDINANCE No. 09-09-21-02

**ORDINANCE AUTHORIZING A TRAFFIC CONTROL DEVICE**  
**ON CYRPESS LANE AT THE INTERSECTION WITH**  
**HARMONY DRIVE**

**WHEREAS**, the Illinois Vehicle Code (625 ILCS 5/11 et seq.) and Chapter 10.04 of the North Aurora Municipal Code authorize the Village to determine the location of local traffic control signs; and

**WHEREAS**, the Village engineer has determined that Cypress Lane at the intersection with Harmony Drive meets State warrants for a stop sign; and

**WHEREAS**, placement of a stop sign on Cypress Lane at the intersection with Harmony Drive is in the best interests of the Village for the safety of the school children who walk to Goodwin School.

**NOW, THEREFORE, Be It Ordained**, by the President and the Board of Trustees of the Village of North Aurora as follows:

1. That the recitals set forth above are herein adopted and incorporated in this Ordinance as the material findings of the President and the Board of Trustees.
2. A stop sign is hereby authorized and directed to be placed on Cypress Lane at the intersection with Harmony Drive consistent with the State Manual as soon as is reasonably practical by the appropriate Village personnel.
3. That compliance with the stop sign consistent with Village ordinances shall be enforced from and after the placement of the stop sign as provided in this Ordinance.
4. The Ordinance shall take immediate force and effect from and after its passage and publication as required by law.


