**AN ORDINANCE LEVYING THE TAXES FOR THE WATERFORD OAKS  
SPECIAL SERVICE AREA #4 FOR THE FISCAL YEAR  
BEGINNING JUNE 1, 2009 AND ENDING MAY 31, 2010**

WHEREAS, Ordinance No. 96-24 establishing the Waterford Oaks Special Service Area was passed on July 22, 1996; and

WHEREAS, the cost for maintenance of the Special Service Area is \$4,032.00;  
and

WHEREAS, the ordinance establishing the Waterford Oaks Special Service Area was recorded in the Kane County Recorder of Deeds Office and filed with the Kane County Clerk's Office, all according to law; and

WHEREAS, the legal description of the Waterford Oaks Special Service Area is attached as Exhibit A and incorporated herein.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of North Aurora, Illinois, as follows:

1. That the foregoing recitals as set forth above are incorporated herein expressly as the findings of the Board of Trustees;
2. That the amount of \$4,032.00 shall be levied as the Special Service Area tax for the fiscal year beginning June 1, 2009 and ending May 31, 2010 for the Waterford Oaks Special Service Area;
3. This Ordinance shall be in full force and effect immediately upon its passage and publication, in pamphlet form, as required by law.
