**ORDINANCE AMENDING THE ZONING PROVISIONS OF THE NORTH AURORA  
MUNICIPAL CODE TO ALLOW TATTOO PARLORS AS A PERMITTED USE IN THE B-2  
GENERAL BUSINESS DISTRICT, I-1 LIMITED INDUSTRIAL DISTRICT AND I-2  
GENERAL INDUSTRIAL DISTRICT**

(Petition #15-01; Text Amendments to the Zoning Ordinance)

**WHEREAS**, the Village of North Aurora maintains a Zoning Ordinance which is found in Title 17 of the Code of North Aurora, Illinois; and,

**WHEREAS**, the Community and Economic Development Director has identified and recommends text amendments to the Zoning Ordinance as set forth herein; and,

**WHEREAS**, a public hearing to consider text amendments to the Zoning Ordinance has been conducted by the Village of North Aurora Plan Commission on February 3, 2015 pursuant to appropriate and legal notice; and,

**WHEREAS**, the Plan Commission has filed its recommendations with the President and Board of Trustees recommending approval of the text amendments described herein, classifying Tattoo Parlors as a permitted use in the B-2 General Business District, I-1 Limited Industrial District and I-2 General Industrial District; and,

**WHEREAS**, the President and Board of Trustees find that the findings and recommendations of the Plan Commission are reasonable, consistent with the general goals and purposes of the Zoning Code and are in the best interests of the Village.

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Trustees of the Village of North Aurora, Kane County, Illinois, as follows:

**SECTION 1:** The recitals set forth above are adopted and incorporated herein as the material findings of the President and Board of Trustees.

**SECTION 2:** Title 17, Chapter 8, Section 2.A of the Code of North Aurora, Illinois is hereby amended to read in part, as follows:
