**AN ORDINANCE ADOPTING THE LATEST STATE OF ILLINOIS
PLUMBING CODE**

WHEREAS, on April 24, 2014 the Illinois Department of Public Health adopted the latest official version of the Illinois Plumbing Code, and

WHEREAS, the Illinois Plumbing Code establishes the minimum regulations governing the design, installation, and construction of plumbing systems by providing reasonable safeguards for sanitation to protect the public health against the hazards of inadequate, defective or unsanitary plumbing systems and installations, and

WHEREAS, the adoption of the Illinois Plumbing Code, and any subsequent amendments to, would be in the best interest of the Village of North Aurora, and

WHEREAS, three copies of the Illinois Plumbing Code have been on file in the office of the Village of North Aurora Clerk for more than thirty (30) days prior to passage of this Ordinance.

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of North Aurora, Kane County, Illinois as follows:

1. Adoption. Three copies of the Illinois Plumbing Code are on file in the office of the village clerk of the Village of North Aurora. The said code is adopted as the Plumbing Code in the Village of North Aurora, Kane County, Illinois. Each and all of the regulations of the Illinois Plumbing Code referred to, adopted and made part hereof as if fully set out in this chapter, with the additions, insertions, deletions, and changes, if any, prescribed in Section 3 of this ordinance. Such code shall be kept available in the village clerk's office for public use, inspection and examination.
2. Inconsistent Ordinances Repealed. That all Ordinances or parts of Ordinances in conflict herewith are repealed.
3. Additions, Intersections, and Changes. That the following sections are hereby revised as follows:

No additions, insertions or changes to the Illinois Plumbing Code.
4. Effective Date. This Ordinance shall be in full force and effect from 2nd day of March, 2015.
