

ORDINANCE NO. 2011-02

**ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BRAWLEY, CALIFORNIA,
ESTABLISHING, AMENDING CHAPTER 17 RELATING TO TRUCK PARKING.**

The City Council of the City of Brawley, California, does ordain as follows:

SECTION 1: Section 17.95-2(i) of the Brawley Municipal Code is hereby amended to read as follows:

Section 17.95-2(i). In addition to the parking of truck tractors pursuant to permit as provided herein, truck tractors and trailers may be parked without a parking permit for a continuous period not to exceed forty-eight (48) hours on streets designated as follows:

- a) The east side of So. 8th Street from G Street to K Street.
- b) The west side of So. 8th Street from G Street to I Street.
- c) The west side of So. 9th Street from D Street to K Street.
- d) The north side of River Drive from North Cesar Chavez Street to North Palm Avenue.
- e) The east side of So. Palm Avenue from Main Street to H Street.
- f) The south side of E Street from No. Palm Avenue to No. Eastern Avenue.
- g) The west side of No. Eastern Avenue from D Street to Main Street.
- h) The south side of Malan Street from So. Imperial Avenue to Vine Avenue.
- i) The south side of Malan Street from So. Cesar Chavez Street to So. Eastern Avenue.

Nothing in this section shall be constructed to allow the parking of a trailer loaded with combustible material within fifty feet (50) of a residential use.

SECTION 2: This ordinance shall be effective thirty (30) days after its adoption and the City Clerk shall cause a certified copy of this ordinance to be published one time within fifteen (15) days after its adoption in the Imperial Valley Press, a newspaper of general circulation printed in Imperial County and circulated in the city of Brawley.
