## ORDINANCE NO. 2023-04

AN ORDINANCE AMENDING CHAPTER 13.12 OF THE BUTTE-SILVER BOW 1 MUNICIPAL CODE (B-SB MC) ENTITLED "SOLID WASTE MANANGEMENT 2 FACILITY", SPECIFICALLY AMENDING SECTION 13.12.070, AND PROVIDING 3 FOR AN EFFECTIVE DATE HEREIN. 4 5 SECTION 1: AMENDMENT: Ordinance No. 410 Section 1 and Section 13.12.070 of the Butte-Silver Bow Municipal Code 6 7 (B-SB MC) shall be and are hereby amended to read 8 as follows: "13.12.070 - Use of solid waste 9 landfill 10 facility. A. SAME. 11 12 B. SAME 13 C. Special Solid Wastes; Tipping Fee. Any materials meeting the definition of solid waste 14 15 that are not generated in the normal course of 16 operation of a commercial or industrial user or the residential user of property shall be deemed 17 18 to be special solid waste. The city-county shall 19 collect a tipping fee for disposal of special

1	solid waste at the city-county solid waste
2	landfill at the time of disposal. The schedule
3	for tipping fees is attached to the ordinance
4	codified in this chapter as Schedule II. The
5	schedule may be amended by the council of
6	commissioners by ordinance. The tipping fees
7	shall be collected by the department of public
8	works and transferred to the city-county
9	treasurer who shall deposit all such fees in the
10	solid waste landfill access fund.

## ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City and County of Butte-Silver Bow (we, us or Company) may be required by law to provide to you certain written notices or disclosures. ## Getting paper copies
