7	SECTION 4:	Amendment: Section 2.88.040 of Ordinance No. 09-14
8		of the Butte-Silver Bow Municipal Code (B-SB MC)
9		shall read as follows:
10		"2.88.040 Functions, Powers and Duties. In
11		addition to the other provisions of this chapter,
12		the board shall:
13		A. Advise the Animal Services, the Council of
14		Commissioners and Chief Executive regarding the
15		carrying out of the provisions of the animal control
16		regulations set forth in Chapter 6.04 of the B-SB
17		MC;
18		B. Advise and make recommendations to the Animal
19		Service Department to ensure the animal shelter is
20		operated in a clean and safe manner and provides
21		humane treatment to animals confined at the

1		shelter, and is open to the public at convenient
2		times;
3		C. SAME."
4	SECTION 5:	Effective Date. This Ordinance shall be in full
5		force and effect from and after thirty (30) days
6		after its passage and approval.

#### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, City and County of Butte-Silver Bow (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

### Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

## Withdrawing your consent

# All notices and disclosures will be sent to you electronically
