SECTION 1: It is hereby determined that it is advisable and necessary for the Village to dispose of personal property that is no longer necessary or useful to the Village.

SECTION 2: It has been determined that the Village will benefit by selling said equipment by means of public auction, on-line auction, salvage, equipment consignment or best offer of which fees are 3 percent of selling price, or recycling .

SECTION 3: The Village Manager is hereby authorized and directed to dispose of said equipment by means of public auction, on line auction, salvage, equipment consignment, or recycling.


