## **ORDINANCE 21- 38**

### **AN ORDINANCE AMENDING CHAPTER 5.12 OF THE CARPENTERSVILLE MUNICIPAL CODE, AS AMENDED, REGARDING THE MAXIMUM NUMBER OF LIQUOR LICENSES ISSUED**

WHEREAS, the Village of Carpentersville, Kane County, Illinois, is a home rule municipality as contemplated under Article VII, Section 6, of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, subject to said Section, a home rule unit may exercise any power and perform any function pertaining to its government and affairs for the protection of the public health, safety, morals and welfare; and

WHEREAS, Chapter 5.12 of the Carpentersville Municipal Code ("Village Code"), as amended, regulates the sale of alcoholic liquor in the Village and provides for the licensing of retail liquor dealers; and

WHEREAS, the Village President and Board of Trustees of the Village desire to amend Chapter 5.12.290 of the Village Code to update the maximum number of Class D licenses authorized in the Village; and

WHEREAS, the Village President and Board of Trustees have determined that it will serve and be in the best interest of the Village and its residents to amend Class D of the Village Code as set forth in this Ordinance;

WHEREAS, the Village President recommends and authorizes the issuance of a liquor license to RE25 Pizza Inc. dba Rosatis Pizza.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Carpentersville, Illinois as follows:

#### **SECTION 1: RECITALS.**

The foregoing recitals are incorporated into and made a part of this Ordinance as the findings of the Village President and Board of Trustees.

## SECTION 2: NUMBER OF LICENSES.

The Village President and Board of Trustees approves the issuance of the liquor license described herein, and the number of available licenses is hereby changed, consistent with Title, 5, Chapter 5.12.290 of the Village Code, to reflect the newly issued license herein.

**SECTION 3:** If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

**SECTION 4:** All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION 5:** This Ordinance shall be in full force and effect upon its approval and publication in pamphlet form (which publication is hereby authorized) as provided by law.
