AN ORDINANCE AMENDING SECTION 10.32.010 – LIMITED PARKING OF THE MUNICIPAL CODE FOR 15-MINUTE LIMITED DURATION PARKING ON VARIOUS STREETS WITHIN THE DOWNTOWN DISTRICT

WHEREAS, the Village is authorized to enact certain ordinances and make rules and regulations proper or necessary in accordance with the Illinois Municipal Code (65 ILCS 5/1-2-1); and

WHEREAS, the Vehicle Code (625 ILCS 5/11-208 – Power of Local Authorities) authorizes municipalities the ability to regulate parking; and

WHEREAS, an audit of downtown traffic signs identified inconsistencies with restrictions in the downtown area;

WHEREAS, a proposed addition of one new 15-minute parking space on W. Main Street will service the various businesses on the block between High Road and Jandus Road;

WHEREAS, the Mayor and Village Board of Trustees have determined that the amendment to the Municipal Code is in the best interest of the Village of Cary.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Cary as follows:

SECTION 1: That the above recitals are incorporated as if fully set forth herein.

SECTION 2: Sec. 10.32.010. - Limited parking.

No person shall park any vehicle between the hours of 6:00 a.m. and 6:00 p.m., unless otherwise specified herein, for longer than the time indicated on the following streets and in the following locations:

A. *Fifteen (15) minutes.*

1. Spring Street, east side, from a point one hundred ninety three (193) feet north of the north curb line of Cary Street, north twenty four (24) feet to a point.

- ~~2. Jandus Road, west side, from a point three hundred sixty (360) feet northwest of the north curb line of Cary Street, northwest twenty two (22) feet to a point.~~
- ~~3.1.~~ Crystal Street, north side, from a point eighty-three (83) feet northwest of the pedestrian traffic signal at the intersection of Crystal Street and West Main Street, to a point ninety-five (95) feet northwest of that same pedestrian traffic signal.
- ~~4.2.~~ ~~Two (2)~~ Four (4) parking spaces on the south side of the parking lot that is immediately north of the Village Hall building.
- ~~5.3.~~ ~~The two (2) northernmost parking spaces on Stonegate Road, immediately in front of the Village Hall.~~
- ~~6.4.~~ Spring Street, east side, the parking space thirty-six (36) feet from the northern curb line of Cary ~~Street Road~~, north to a point sixty-two (62) feet from the northern curb line of Cary ~~Street Road~~, excepting therefrom those portions where parking is prohibited at any time.
- ~~7.5.~~ The one (1) easternmost parking space on the south side of W. Main Street, immediately west of Spring Street.

SECTION 3: All Ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed to the extent of such conflict.

SECTION 4: If any part or parts of this Ordinance shall be held invalid for any reason such decision shall not affect the validity of the remaining part or parts of this Ordinance.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage and approval according to law.
