ORDINANCE NO. 534

APPOINTMENT ORDINANCE
FOR THE CITY OF CASEY, ILLINOIS

BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF CASEY, ILLINOIS, THAT:

Section 1. That the term of all appointed officers of the City of Casey, Illinois, shall be for the year from May 01, 2023 to April 30, 2024, except as may otherwise be provided by law, or as otherwise set forth herein, subject to the right of the City Council to remove or discharge any officer or employee as provided by law, and provided also that if the City Council should in the next fiscal year discontinue or consolidate any office or discontinue any position of employment, this appointment is subject to such further action of the City Council in that respect.

Section 2: Appointments: See Exhibit A, which is attached hereto and hereby incorporated by reference as though fully stated herein.

Section 3: This Ordinance shall become effective upon approval and passage as required by law.

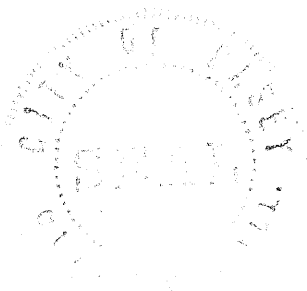
