


## ANALYSIS

**ORDINANCE NO. 2023-0040**

An ordinance amending Title 6 – Salaries of the Los Angeles County Code to add and establish the salary for one employee classification; and add, delete and/or change certain employee classifications and the number of ordinance positions in various departments to implement the findings of classification studies.
