**RESOLUTION DECLARING THE RESULTS OF THE CITY OF OAKLAND GENERAL MUNICIPAL ELECTION HELD ON TUESDAY, NOVEMBER 5, 2024**

**WHEREAS**, pursuant to California law and section 1101 of the Charter of the City of Oakland, a General Municipal Election was duly and regularly held in the City of Oakland on Tuesday, November 5, 2024; and

**WHEREAS**, the Alameda County Registrar of Voters has prepared and submitted a certified statement of the results of said General Municipal Election; and

**WHEREAS**, the City Clerk has canvassed the election returns of said General Municipal Election pursuant to law; and

**WHEREAS**, the City Clerk has certified the results for the General Municipal Election attached hereto as **Attachment A**; and

**WHEREAS**, California Elections Code sections 10263 and 15400 provide that the governing body shall declare the results of each election under its jurisdiction as to the persons elected and the measures voted on at the election; now, therefore, be it

**FURTHER RESOLVED:** That the City Council hereby determines and declares that a majority of the votes cast on the question of whether to Recall are “Yes,” the question is declared PASSED and the Mayor is removed from office; and be it

**FURTHER RESOLVED:** That the results of the votes cast for and against the measure that was presented to the electors in the City of Oakland Wildfire Prevention Zone at said election are as follows:

Proposed Ordinance

Measure to levying a special tax for 20 years in the “Wildfire Prevention Zone” defined in the measure), to prevent wildfires by implementing City of Oakland prevention plans, including vegetation management, evacuation route protection, enhanced fire patrols during high danger periods, and goat grazing at annual rates of \$99/single-family parcel, \$65/condominium/multifamily unit; nonresidential parcels based on a formula, generating \$2,670,000 in 2025-26, with cost of living increases, citizens’ oversight and audits.

Measure to 1) fund Citywide violence reduction services, such as 9-1-1 dispatch, community policing, mobile crisis responders, and violence interruption, and 2) increase police and fire minimum staffing, by extending and increasing both the existing parking tax surcharge to 10% and the existing parcel tax to \$198 annually for single-family parcels, and other parcels as specified, with exemptions and reductions, for 9 years, raising approximately \$47,400,000 annually, with oversight and auditing.

Against the Measure:	46,602	29.20%

Proposed Ordinance

Measure amending the City Charter and Oakland Municipal Code to, among other things, revise qualifications and restrictions for service and removal procedures, specify the vote threshold for action and increase minimum staffing requirements for the Public Ethics Commission; allow the Commission to set

City Attorney and City Auditor salaries biannually rather than annually; and amend the Lobbyist Registration Act to restrict payments and expenses incurred by local government lobbyists.

For the Measure:	110,317	73.30% ( <i>Passed</i> )
Against the Measure:	40,186	26.70%

**FURTHER RESOLVED:** That the City Council hereby determines and declares that the following measures have passed or have failed as shown below:

- 1) **Measure MM did** receive two-thirds (2/3) of the votes cast and is hereby declared **PASSED**;
- 2) **Measure NN did** receive a majority of the votes cast and is hereby declared **PASSED**; and
- 3) **Measure OO did** receive a majority of the votes cast and is hereby declared **PASSED**

**FURTHER RESOLVED:** That the total number of registered voters was 252,413 and the canvas of the returns of said General Municipal Election show that the total number of ballots cast at the General Municipal Election was 173,416 (or 68.70%); and be it

**FURTHER RESOLVED:** That the City Council hereby declares that the Official Canvass Summary report on file in the Office of the City Clerk, containing within the number of votes cast at each precinct for each candidate and for and against each measure, be and is hereby adopted.
