

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DALY CITY AMENDING
CHAPTER 2.44 OF THE MUNICIPAL CODE RE: TEMPORARY DISABILITY

The City Council of the City of Daly City, DOES ORDAIN as follows:

SECTION 1. Chapter 2.44 of the Municipal Code is hereby amended to read as follows:

Chapter 2.44 TEMPORARY DISABILITY

Sections:

- 2.44.010 Applicability.**
- 2.44.020 Indemnity insurance payment.**
- 2.44.030 Subrogation Rights.**

- 2.44.010 Applicability.**

This Chapter refers to temporary disability only.

- 2.44.020 Indemnity insurance payment.**

All payments to which an employee of the city is entitled to by virtue of insurance of the city, which the insurer would be obligated to make as disability indemnity of the insured, the insurer shall pay to the insured.

- 2.44.030 Subrogation Rights.**

The city shall be subrogated to any rights of an injured employee against any third party for any payments of salary granted under the on the job injury leave of absence provided by Section 9 of the Rules and Regulations of the Classified Service.

SECTION 2. Environmental Determination.

The City Council of the City of Daly City finds and determines that the implementation of measures described in this Chapter is in furtherance police powers of the City of Daly City, and that these purposes are exempt from the provisions of the California Environmental Quality Act (CEQA); Chapter 3 (commencing with Section 21100) of Division 13 of the Public Resources Code, as provided in categorical exemption Classes 1, 4, 5, 7, 8, 9, and or 21 of the CEQA Guidelines (Title 14, *California Code of Regulations*, Sections 15301-15329).

SECTION 3. Effective Date and Publication: This Ordinance shall be in full force and effect thirty (30) days from and after its passage. This Ordinance shall be published according to law.

SECTION 4. Severability: If any section, subsection or sentence of this Ordinance is found by a court of competent jurisdiction to be invalid or unlawful, the City Council finds and declares that the remainder of this ordinance would be and is enforceable and would have been adopted notwithstanding the finding of invalidity as to any section, subsection or sentence.
