1           Section 6.       Subsection 52 of Section 2.6 of Ordinance 452 adopted on October 17, 2006,  
2 pursuant to Ordinance No. 452.223, is repealed in its entirety. Subsection 52 of Section 2.6 established a  
3 fifty miles per hour speed limit on the entire northerly half, and on the County portions of the southerly half  
4 of Brookside Avenue between I-10 and Union Street, a total distance of approximately 1.33 miles, in the  
5 Cherry Valley area.

6           Section 7.       Subsection 89 of Section 2.6 of Ordinance 452 adopted on February 7, 2017,  
7 pursuant to Ordinance No. 452.242, is repealed in its entirety. Subsection 89 of Section 2.6 established a  
8 fifty miles per hour speed limit on De Portola Road between Pauba Road and Glen Oaks Road, a total  
9 distance of approximately 4.18 miles, in the Temecula area.

10          Section 8.       Subsection 4 of Section 3.6 of Ordinance 452 adopted on March 29, 2016,  
11 pursuant to Ordinance No. 452.240, is repealed in its entirety. Subsection 4 of Section 3.6 established a  
12 twenty-five miles per hour speed limit on Leon Road between Borel Road and Auld Road, a total distance  
13 of approximately 0.76 miles, in the French Valley area.
