

ORDINANCE NO. 2024-0489

**AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF SPOKANE COUNTY, WASHINGTON AMENDING SPOKANE COUNTY CODE SECTION 46.61.4155.1**

**WHEREAS**, pursuant to the Constitution and laws of the State of Washington, Spokane County, Washington ("County") is a class A county duly organized and existing; and

**WHEREAS**, pursuant to RCW 36.01.030, the powers of Spokane County can only be exercised through the Board of County Commissioners of Spokane County, Washington ("Board"); and

**WHEREAS**, pursuant to RCW 36.32.120(6), the Board has the care of County property and the management of County funds and business; and

**WHEREAS**, pursuant to RCW 36.32.120(7), the Board may make and enforce by ordinance all such police and sanitary regulations that are not in conflict with state law; and

**WHEREAS**, pursuant to RCW 46.08.020, the Board may adopt vehicle and traffic regulations that are not in conflict with title 46 RCW; and

**WHEREAS**, the County Engineer has conducted a Traffic Engineering Study as to revise and create a new school zone designation on Freya Street and Day-Mt Spokane Road; and

**WHEREAS**, the County Engineer has recommended that a school speed zone would serve the best interests of the public; and

**WHEREAS**, having held a public hearing and taken testimony on this matter, the Board agrees with the County Engineer's recommendation.

**NOW THEREFORE BE IT ORDAINED** by the Board of County Commissioners of Spokane County, Washington, that Spokane County Code Section 46.61.4155.1 be amended as follows:

**Delete from Section No. 46.61.4155.1 Twenty miles per hour (a).**

**Freya Street** – Moody Road to four hundred twenty feet south of Day-Mt Spokane Road

**Add to Section No. 46.61.4155.1 Twenty miles per hour (a).**

**Freya Street** – Moody Road to Day-Mt Spokane Road

**Day-Mt Spokane Road** – Freya Street to three hundred thirty feet east of Sycamore Street

**BE IT FURTHER ORDAINED** by the Board that the County Engineer is directed and authorized to cause to be posted and maintained signs in accordance with SCC 46.61.5701 and the Washington State Department of Transportation's "Manual for Signing."

**BE IT FURTHER ORDAINED** by the Board that this Ordinance shall take effect upon the placement of said signs.
