

ORDINANCE NO. 2024-0490

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF SPOKANE COUNTY, WASHINGTON AMENDING SPOKANE COUNTY CODE SECTION 46.61.5701

WHEREAS, pursuant to the Constitution and laws of the State of Washington, Spokane County, Washington ("County") is a class A county duly organized and existing; and

WHEREAS, pursuant to RCW 36.01.030, the powers of Spokane County can only be exercised through the Board of County Commissioners of Spokane County, Washington ("Board"); and

WHEREAS, pursuant to RCW 36.32.120(6), the Board has the care of County property and the management of County funds and business; and

WHEREAS, pursuant to RCW 36.32.120(7), the Board may make and enforce by ordinance all such police and sanitary regulations that are not in conflict with state law; and

WHEREAS, pursuant to RCW 46.08.020, the Board may adopt vehicle and traffic regulations that are not in conflict with title 46 RCW; and

WHEREAS, the County Engineer has conducted a Traffic Engineering Study as to restricting parking on Fruit Hill Rd for public safety due to citizen complaints and the request of additional signage by the Sheriff's office; and

WHEREAS, the County Engineer has recommended that no parking along both sides of Fruit Hill Road would serve the best interests of the public; and

WHEREAS, having held a public hearing and taken testimony on this matter, the Board agrees with the County Engineer's recommendation.

NOW THEREFORE BE IT ORDAINED by the Board of County Commissioners of Spokane County, Washington, that Spokane County Code Section 46.61.5701 be amended as follows:

Add to Section No. 46.61.5701 No Parking.

Fruit Hill Road – along both sides from two thousand feet east of Upriver Drive to three thousand six hundred feet east of Upriver Drive.

BE IT FURTHER ORDAINED by the Board that the County Engineer is directed and authorized to cause to be posted and maintained signs in accordance with SCC 46.61.5701 and the Washington State Department of Transportation's "Manual for Signing."

BE IT FURTHER ORDAINED by the Board that this Ordinance shall take effect upon the placement of said signs.
