

ORDINANCE NO. 2024-0708

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF SPOKANE COUNTY, WASHINGTON AMENDING SPOKANE COUNTY CODE SECTION 46.61.4155.2

WHEREAS, pursuant to the Constitution and laws of the State of Washington, Spokane County, Washington (“County”) is a class A county duly organized and existing; and

WHEREAS, pursuant to RCW 36.01.030, the powers of Spokane County can only be exercised through the Board of County Commissioners of Spokane County, Washington (“Board”); and

WHEREAS, pursuant to RCW 36.32.120(6), the Board has the care of County property and the management of County funds and business; and

WHEREAS, pursuant to RCW 36.32.120(7), the Board may make and enforce by ordinance all such police and sanitary regulations that are not in conflict with state law; and

WHEREAS, pursuant to RCW 46.08.020, the Board may adopt vehicle and traffic regulations that are not in conflict with title 46 RCW; and

WHEREAS, pursuant to RCW 46.61.415, whenever the Board determines on the basis of an engineering and traffic investigation that the maximum speed permitted under RCW 46.61.400 or 46.61.440 is greater or less than is reasonable and safe under the conditions found to exist upon a highway or part of a highway, the Board may determine and declare a reasonable and safe maximum limit thereon; and

WHEREAS, the County Engineer has conducted a Traffic Engineering Study as to set 25 MPH speed limit on various road that are outside the Federal Air Urban Boundary; and

WHEREAS, the County Engineer has recommended that a speed limit of 25 MPH would serve the best interests of the public; and

WHEREAS, having held a public hearing and taken testimony on this matter, the Board agrees with the County Engineer’s recommendation.

NOW THEREFORE BE IT ORDAINED by the Board of County Commissioners of Spokane County, Washington, that Spokane County Code Section 46.61.4155.2 be amended as follows:

Add to Section No. 46.61.4155.2 Twenty-Five miles per hour.

Meadowview Road from Barker Road to 21st Court
21st Court from Barker Road to east end
22nd Court from Meadowview Road to east end
Meadow Court from Meadowview Road to north end

Clara Road from 15th Avenue to 12th Court (FAUB)
McMillan Road from 15th Avenue to 11th Avenue (FAUB)
Kayla Road from 15th Avenue to 13th Avenue
Kayla Court from 11th Avenue to north end
Whistler Court from 11th Avenue to north end
Hodges Street from South End to 11th Avenue

Cavalier Street from 15th Avenue to 11th Avenue
Colonial Drive from 15th Avenue to 11th Avenue and from 11th Avenue to north end
Meyers Road from South End to 11th Avenue
Meyers Court from 11th Avenue to north end
15th Avenue from Clara Road (FAUB) to east end
13th Avenue from McMillian Road to Kayla Road
11th Avenue from McMillan Court (FAUB) to east end
Ellie Mae Avenue from west end to Colonial Drive

Sheridan Road from Chattaroy Road to Yearling Road
Ranchette Road from Yearling Road to Avonlea Road
Ranchette Court from Avonlea Road to north end
Yearling Road from Ranchette Road to east end
Avonlea Road from two hundred feet west of Ranchette Road to two hundred feet east of Ranchette Road

Custer Street from 65th Avenue to north end
65th Avenue from Dearborn Road (FAUB) to east end

Remove from Section No. 46.61.4155.2 Twenty-Five miles per hour.

65th Avenue from Dearborn Road (FAUB) to Custer Road

BE IT FURTHER ORDAINED by the Board that this Ordinance shall take effect when appropriate signs giving notice thereof are erected.
