**RESOLUTION**  
Spokane County Traffic Code  
46.61.4155.1

WHEREAS, Resolution No. 67-25, passed and adopted by the Board of County Commissioners of Spokane County, Washington, on the 10th day of January, 1967, adopted the "Spokane County Traffic Code"; and

WHEREAS, It is now apparent that the best interests of the public would be served by certain revisions to said Traffic Code; and

WHEREAS, A Traffic Engineering Study has been made.

THEREFORE, BE IT RESOLVED By the Board of County Commissioners of Spokane County, Washington, that said Traffic Code be and the same is hereby revised and amended as follows:

**"Twenty Miles Per Hour" school speed zones:**

**Add to Section No. 46.61.4155.1(b)**

**JOHANNSEN ROAD from three hundred feet west of Orchard Road to three hundred feet east of Orchard Road.**

**Delete from Section No. 46.61.4155.1(a)**

**HASTINGS ROAD from three hundred feet west of Bellwood Drive to three hundred feet east of Normandie Street between the hours of seven-thirty to nine a.m. and two to three-thirty p.m. school days.**

**Add to Section No. 46.61.4155.1(b)**

**HASTINGS ROAD from two hundred feet east of Bellwood Drive to one hundred feet west of Ruby Road.**

**Delete from Section No. 46.61.4155.1(a)**

**CHARLES ROAD from three hundred feet east of Tormey Road to one thousand feet east of Tormey Road.**

**Add to Section No. 46.61.4155.1(b)**

**CHARLES ROAD from one hundred feet east of Tormey Road to one thousand two hundred feet east of Tormey Road.**

**Delete from Section No. 46.61.4155.1(a)**

**HALLETT ROAD from one thousand two hundred feet east of Grove Road to one thousand nine hundred feet east of Grove Road.**

**Add to Section No. 46.61.4155.1(b)**

**HALLETT ROAD from one thousand three hundred feet west of Abbott Road to one hundred fifty feet west of Abbott Road.**

**Delete from Section No. 46.61.4155.1(a)**

**UPRIVER DRIVE from three hundred feet west of Bessie Road to Marguerite Road.**

**Add to Section No. 46.61.4155.1(b)**

**UPRIVER DRIVE from three hundred feet west of Bessie Road to three hundred feet east of Bessie Road.**

The County Engineer is hereby directed and authorized to cause to be posted and maintained signs in accordance with this Resolution and the Washington State Department of Transportation's "Manual for Signing".

The restrictions authorized by this resolution shall take effect upon the placement of signs.
