WHEREAS, on November 3, 2016, the corporate authorities of the City of Elmhurst ("City") approved Ordinance Number MCO-25-2016 entitled "An Ordinance to Amend Section 36.10(b) entitled "The Fee for the Various Classes of Licenses shall be as Follows:" of Article II, entitled "Retail License" of Chapter 36, entitled "Liquor" of the Municipal Code of Ordinances of the City of Elmhurst, Illinois" and Ordinance Number MCO-26-2016 entitled "An Ordinance to Amend Section 36.10(c) entitled "The Annual Fee for a Class BP License for 2016" of Article II, entitled "Retail License" of Chapter 36, entitled "Liquor" of the Municipal Code of Ordinances of the City of Elmhurst, Illinois" (collectively the "Ordinances"); and

WHEREAS, due to scrivener's errors, the Ordinances erroneously reflected the amount of the liquor license fee imposed for Class BP liquor licenses; and

WHEREAS, it is in the City's best interest to correct the scrivener's errors in the Ordinances to reflect the correct liquor license fee amount to be imposed for Class BP liquor licenses for 2016 to be Five Thousand Four Hundred Nine (\$5,409.00) Dollars.

NOW, THEREFORE, be it ordained by the Mayor and City Council of the City of Elmhurst, DuPage and Cook Counties, Illinois as follows:

Section 1. The facts and statements contained in the preamble clauses to this Resolution are found to be true and correct and are hereby adopted.

Section 2. It is hereby determined that it is advisable, necessary, and in the public interest that the City correct the liquor license fee amount to be imposed for Class BP liquor licenses for 2016 to be Five Thousand Four Hundred Nine (\$5,409.00) Dollars both in Section 36.10(b) entitled "The Fee for the Various Classes of Licenses shall be as Follows:" and Section 36.10(c) entitled "The Annual Fee for a Class BP License for 2016" in Article II, entitled "Retail License" of Chapter 36, entitled "Liquor" of the Municipal Code of Ordinances of the City of Elmhurst, Illinois".

Section 3. This Ordinance shall be in full force and effect upon its passage, approval and publication in accordance with law.
