AN ORDINANCE AMENDING SECTION 44.120, ENTITLED "NO PARKING ZONES ENUMERATED," OF DIVISION 3, ENTITLED "PARKING RESTRICTIONS," OF ARTICLE VII, ENTITLED "STOPPING, STANDING AND PARKING," OF CHAPTER 44, ENTITLED "MOTOR VEHICLES AND TRAFFIC," OF THE ELMHURST MUNICIPAL CODE (PARKING RESTRICTIONS ON EAST SIDE OF CHURCH ROAD FROM CHURCH COURT TO 300 FEET NORTH OF CHURCH COURT)

WHEREAS, pursuant to Section 11-208 (a) (1) of the Illinois Vehicle Code (625 ILCS 5/11-208 (a) (1)), the City of Elmhurst (the "City") is empowered to regulate the parking of vehicles upon streets under its jurisdiction; and

WHEREAS, the City determined that parking restrictions were appropriate to prohibit parking on the east side of Church Road from Church Court to 300 feet north of the centerline of Church Court; and

WHEREAS, the specific restrictions call for no parking on the east side of Church Road from Church Court to 300 feet north of the centerline of Church Court; and

WHEREAS, the City deems it is necessary, desirable, and in the best interest of the public to amend Section 44.120 of the Elmhurst Municipal Code.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and City Council of the City of Elmhurst, DuPage and Cook Counties, Illinois as follows:

Section 1: The facts and statements contained in the preamble clauses to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section 2: That Division 3, entitled "Parking Restrictions," of Article VII, entitled "Stopping, Standing and Parking," of Chapter 44, entitled "Motor Vehicles and Traffic," of the Elmhurst Municipal Code is amended as follows:

By amending Section 44.120, entitled "No parking zones enumerated," as follows:

By adding the following language to read as follows:

"On the east side of Church Road from Church Court to 300 feet north of the centerline of Church Court."

<u>Section 3</u>: The remainder of Section 44.120, entitled "No parking zones enumerated," of Article VII, entitled "Stopping, Standing and Parking," of Chapter 44, entitled "Motor Vehicles and Traffic," of the City of Elmhurst Municipal Code shall remain in full force and effect and unchanged.

<u>Section 4:</u> That the Chief of Police shall cause the appropriate signage to be posted at the aforementioned locations.

Section 5: That all ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.

That this Ordinance shall be in full force and effect from and after its Section 6: passage, approval, and publication in pamphlet form in the manner provided by law, and after the installation of the appropriate signage.
