ORDINANCE NO. 14-36

AN ORDINANCE AMENDING THE HARWOOD HEIGHTS CODE OF ORDINANCES TO RESTRICT BOAT PARKING AND STORAGE

WHEREAS, the Village of Harwood Heights (hereinafter, “the Village”) is a home rule unit of government pursuant to Section 6(a), Article VII of the 1970 Illinois Constitution; and

WHEREAS, pursuant to its home rule power, the Village may exercise any power and perform any function relating to its government and affairs; and

WHEREAS, the Corporate Authorities hereby find that modification of the village code to revise the current language restricting boat parking and storage to better define the restrictions..

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Harwood Heights, County of Cook, Illinois, in the exercise of their home rule powers, that the Village Code be amended to read as follows:

SECTION 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

SECTION 2. Title. This Ordinance shall be known and may hereafter be referred to as the *Modification Of Boat Parking and Storage Ordinance*.

SECTION 3. Enactment. Title 10 (“Vehicles and Traffic”), Chapter 10.52 (“Stopping, Standing and Parking”), Section 10.52.140 (“Recreational Vehicles, Boats and Campers”) of the Harwood Heights Village Code, shall be, amended (**bold font indicating new text** with deleted text ~~struck out~~) to read as follows:

10.52.140 Parking of recreational vehicles, boats and campers.

A. In ~~residence~~ **residential** districts, one truck camper mounted on a pickup truck not exceeding three-quarter-ton capacity, or one travel or camping trailer having a floor area of not more than one hundred thirty (130) square feet when hitched for travel, may be stored in a rear yard, in a garage, carport, screen shelter or similar structure designed so as to

substantially conceal the trailer or camper from the view of the adjoining property owners. No such truck camper or camping trailer may be parked on any street longer than is reasonably necessary for the expeditious loading or unloading of such camper or trailer.

B. It shall be prohibited to park any boat, **personal water craft, snow mobiles** or ~~boat~~ trailers on any street in the village. In a residential district it shall be prohibited to ~~park or~~ store any boat, or boat trailer that exceeds twenty-four (24) feet in length. No more than one boat, **personal water craft, snow mobile**, boat trailer, or combination of boat, **personal water craft, snow mobile** and trailer may be stored on any lot in a residential district. Any boat, **personal water craft, snow mobile** and/or boat trailer stored in a residential district shall be stored in a rear yard in a garage, carport, screen shelter or similar structure designed so as to substantially conceal the boat, **personal water craft or snow mobile** from the view of surrounding property owners; and provided further that no substantial repair, disassembly, rebuilding operations are conducted thereon.

C. Any person, firm, or corporation which parks, or causes to be parked or stored, a recreational vehicle, camper, boat, **personal water craft, snow mobile** or trailer in violation of the provision herein shall be fined fifty dollars (\$50.00) per occurrence ~~day~~.

SECTION 4. RESOLUTION OF CONFLICTS.

All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 5. SAVING CLAUSE.

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

SECTION 6. IMMEDIATE EFFECTIVE DATE.

This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
