## VILLAGE OF HARWOOD HEIGHTS

### ORDINANCE NO. 14-38

#### AN ORDINANCE AMENDING THE HARWOOD HEIGHTS CODE OF ORDINANCES REGARDING PARKING WORK VEHICLES ON RESIDENTIAL STREETS

**WHEREAS**, the Village of Harwood Heights (hereinafter, “the Village”) is a home rule unit of government pursuant to Section 6(a), Article VII of the 1970 Illinois Constitution; and

**WHEREAS**, pursuant to its home rule power, the Village may exercise any power and perform any function relating to its government and affairs; and

**WHEREAS**, the Corporate Authorities hereby find that modification of the village code to revise the current language restricting work vehicle parking and to better define the restrictions on the parking of trucks.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Board of Trustees of the Village of Harwood Heights, County of Cook, Illinois, in the exercise of their home rule powers, that the Village Code be amended to read as follows:

**SECTION 1. Recitals.** The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

**SECTION 2. Title.** This Ordinance shall be known and may hereafter be referred to as the Parking of Work Vehicles *Ordinance*.

**SECTION 3. Enactment.** Title 10 (“Vehicles and Traffic”), Chapter 10.52 (“Stopping, Standing and Parking”), Section 10.52.130 (“Parking of trucks restricted”) of the Harwood Heights Village Code, shall be, amended (**bold font indicating new text** with deleted text ~~struck-out~~) to read as follows:

#### **10.52.130 Parking of trucks restricted.**

A. No person shall stand or park any **truck**, tractor, semitrailer, trailer or bus on any street **in the village** for longer than sixty (60) minutes, or for a longer period than is necessary for the reasonably expeditious loading or unloading of such vehicle.

**B. No person shall stand or park any second division motor vehicle with a registration of "D" or larger on any business or residential street in the village for a longer period than sixty (60) minutes or for such time as is necessary for the reasonably expeditious loading or unloading of such vehicle or such time required during the day to complete work supported by the motor vehicle.**

**C. No more than one vehicle per household with a "B" registration or determined to be a commercial or work vehicle may be parked on any street within the village between the hours of nine pm and seven am. These vehicles must display a valid Village-issued parking permit that is renewed annually. Resident-owned vehicles must have a current village sticker. Upon application and approval a resident may request a permit for a second vehicle.**

**A commercial or work vehicle is operated for the transportation of persons or property in the furtherance of any commercial or industrial enterprise. A vehicle that possesses at least one of the following characteristics will be considered a commercial or work vehicle.**

- 1. Company logo, decal or insignia**
- 2. Ladder, pipe or equipment racks**
- 3. Equipment or tool boxes**
- 4. Industrial security locks**
- 5. Limousine or taxi**

**D. Effective January 1, 2015, all vehicles with a "B" registration or determined to be a commercial/work vehicle must display a valid Village-issued parking permit. The pass must hang from the inside rear view mirror. Upon application and an annual five (5) dollar fee per permit, a resident may be issued no more than two parking permits.**

- 1. Residents must report lost or misplaced parking passes to the Harwood Heights Police Department. Replacement passes are available by application only and payment of a five-dollar replacement fee.**
- 2. Any misuse of the parking pass shall render the pass invalid and result in its confiscation. The resident to whom the pass was issued shall be cited and fined one hundred dollars**

**(\$100.00). No future parking passes shall be issued to the resident or household originally issued the parking pass when misuse is discovered.**

**3. Vehicles displaying invalid, damaged, altered or expired parking passes will be cited and fined accordingly.**

**4. Nonresident vehicles parked on any street within the village without a parking pass or parking permission will be cited by the police department and fined one hundred dollars (\$100.00).**

E. Any vehicle parked in violation of this section is declared to be a nuisance which may be abated by any police officer by removing such vehicle to the vehicle pound or to an authorized garage, by the institution of a quasi-criminal municipal ordinance violation citation, by the institution of a civil action seeking to abate the nuisance, or by any other action appropriate to abate such nuisance. Any costs or fees, including costs of towing and attorneys' fees and court costs incurred by the village in the enforcement of this section shall be paid by the persons so violating this section.

E. The provisions of subsections A. through D. shall not apply to buses which park in designated bus stands as provided herein.

H. Any person violating the provisions of this section shall be fined no less than fifty dollars (\$50.00) nor more than five hundred dollars (\$500.00) for each offense, and a separate offense shall be deemed committed during each sixty (60) minute period during which a violation occurs.

#### **SECTION 4. RESOLUTION OF CONFLICTS.**

All ordinances in conflict herewith are hereby repealed to the extent of such conflict.

#### **SECTION 5. SAVING CLAUSE.**

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance, which are hereby declared to be separable.

**SECTION 6. IMMEDIATE EFFECTIVE DATE.**

This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law as of January 1, 2015.
