

CITY OF HAZEL PARK
ORDINANCE NO. 07-22

An Ordinance creating Chapter 15.56, Offenses Affecting Government Functions, Sections 15.56.010 through 15.56.040 to Title 15 – Buildings and Construction of the Hazel Park Municipal Code of Ordinances to create offenses affecting government functions for providing false information on documents submitted to the city and to provide for the penalties thereof.

The City of Hazel Park ORDAINS:

Title 15 – Buildings and Construction.

Chapter 15.56 – Offenses Affecting Government Functions

PART I. ADDITION.

Sec. 15.56.010 - Title.

This ordinance may be cited as the "Offenses Affecting Government Functions Ordinance."

Sec. 15.56.020 - False Information on Documents Submitted to City.

No person shall knowingly furnish to any law enforcement officer, city official, city officer, city employee, city appointee, or agent of the city in connection with any license application or renewal, in connection with any property registration application or renewal, in connection with any contractor certification or bid documentation, or in connection with any permit application or renewal.

Sec. 15.56.030 – Penalty.

Any person violating any of the provisions of this chapter shall be responsible for a municipal civil infraction and shall be fined not less than two hundred fifty dollars (\$250.00) and not more than five hundred (\$500.00).

Sec. 15.56.040 – Enforcement Responsibility.

The city manager or the city manager's designee shall be responsible for the enforcement of this chapter.

PART II. REPEAL.

This ordinance hereby repeals any ordinance which conflicts with the provisions hereof.

PART III. EFFECTIVE DATE; PUBLICATION.

The provisions of this ordinance shall become effective ten days after its publication and shall be published within ten days of its adoption by publication of a brief notice in the newspaper circulated in the city stating the date of the enactment and the effective date of the ordinance, a brief statement as to the subject matter of this ordinance and such other facts as the Clerk deems pertinent, and that a copy of the ordinance is available for purchase and/or inspection at the office of the City Clerk.


