SUMMARY OF AN ORDINANCE THAT 1) RESCINDS TITLE 22I AND THE TEXT OF TITLE 20 (INTERIM) – SUBDIVISIONS, 2) REPLACES TITLE 20 (INTERIM) – SUBDIVISIONS WITH THE TEXT OF THE 2021 LOCAL COASTAL PROGRAM IMPLEMENTATION PLAN AS WELL AS STANDARDS RELATED TO THE REGULATIONS IN THE 1982 LCP REGARDING ENVIRONMENTAL HAZARDS, AND 3) RENAMES TITLE 20 AS THE COASTAL ZONING CODE

- 1. Rescind Title 22I, and
- 2. Rescind the text of Title 20 (Interim) Subdivisions, and
- 3. Replace Title 20 (Interim) Subdivisions with the text of the 2021 Local Coastal Program Implementation Plan and 1982 Local Coastal Program regulations related to Environmental Hazards, and
- 4. Rename "Title 20 (Interim) Subdivisions" to "Title 20 Coastal Zoning Code"
