ORDINANCE NO. 4424

**AN ORDINANCE AMENDING SECTION 10.10.010 REGULATING
ONE-WAY STREETS AND ALLEYS WITHIN
THE CITY OF MORRIS, GRUNDY COUNTY, ILLINOIS**

WHEREAS, the City of Morris currently regulates which streets and alleys shall be considered one-way; and

WHEREAS, the City of Morris Street and Alley Committee has deemed it reasonable and necessary to limit traffic to one way in the alleyway located between East Jefferson Street and East Main Street running from East Street to Washington Street as a one-way for eastbound traffic within the City of Morris; and

WHEREAS, Morris City Council is authorized to regulate the use of streets and alleys pursuant to 625 ILCS 5/11-80-2 of the Illinois Municipal Code; and

WHEREAS, the Morris City Council has determined that it is in the best interest of the health, safety and welfare of the residents of the City of Morris to limit the alleyway located between East Jefferson Street and East Main Street running from East Street to Washington Street as a one-way for eastbound traffic within the City of Morris.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE ALDERMEN OF THE MORRIS CITY COUNCIL, GRUNDY COUNTY, ILLINOIS, AS FOLLOWS:

1. That the above recitals constitute the findings of the Morris City Council and are hereby restated and incorporated into the body of this Ordinance as though fully set forth herein.
2. That Section 10.10.010(F) is hereby amended by inserting the following:
 - F. The alleyway located between East Jefferson Street and East Main Street running from East Street to Washington Street as a one-way for eastbound traffic within the City of Morris.

3. The balance of the provisions contained in Section 10.10.10, of the Morris Municipal Code are restated as though fully set forth herein.

4. The Director of Public Works is hereby authorized and directed to purchase and install one-way signs, and to post the same at the above designated location following passage, approval and publication hereof.

5. In the event any Section, Paragraph, sentence, clause or phrase of this Ordinance is declared invalid or unconstitutional for any reason, the remainder of this Ordinance shall not be affected thereby and shall remain in full force and effect.

6. The Morris City Clerk is authorized and directed to publish a true and correct copy of this Ordinance in pamphlet form for a period of not less than ten days.

7. Any Ordinance or Resolution inconsistent with the terms and provisions hereof is hereby repealed and revoked to the extent of any such inconsistencies.

8. This Ordinance shall be effective immediately from and following its passage, approval and publication as required by law.
