**ORDINANCE ESTABLISHING SECTION 44-135 OF THE MORRIS  
MUNICIPAL CODE REGARDING THE PLACEMENT OF STOP SIGNS  
AND SECTION 44-356 OF THE MORRIS MUNICIPAL CODE REGARDING  
PARKING RESTRICTIONS WITHIN THE CITY OF MORRIS, GRUNDY  
COUNTY, ILLINOIS**

WHEREAS, the City of Morris, Street & Alley Committee has investigated and discussed the process for the placement of stop signs and parking restrictions within the City of Morris;

WHEREAS, the Morris City Council has deemed it reasonable and necessary to establish Sec. 44-135 of the Morris Municipal Code regarding placement of designated stop sign intersections within the City of Morris consistent herewith;

WHEREAS, the Morris City Council has deemed it reasonable and necessary to establish Sec. 44-356 of the Morris Municipal Code regarding the location of areas where parking is prohibited or limited within the City of Morris consistent herewith;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND ALDERMEN OF THE MORRIS CITY COUNCIL, GRUNDY COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: That Section 44-135 of the Morris Municipal Code is hereby established to state the following:

The Mayor, with the advice and consent of the Street and Alley Committee, is hereby authorized to place and maintain, or cause to be placed and maintained, stop signs within the City of Morris. Said signs shall be

located in such position and to be provided with letters of a size to be clearly legible in conformance with the state manual and specifications for such signs.

Section 2: That Section 44-356 of the Morris Municipal Code is hereby established to state the following:

The Mayor, with the advice and consent of the Street and Alley Committee, is hereby authorized to place and maintain, or cause to be placed and maintained, no parking, handicapped parking or limited parking locations within the City of Morris. Said signs shall be located in such position and to be provided with letters of a size to be clearly legible in conformance with the state manual and specifications for such signs.


Section 3: That the Director of Public Works is hereby authorized and directed to purchase and install stop signs, no parking, limited parking or handicapped parking signs at the designated locations within thirty (30) days following passage, approval and publication hereof.

Section 4: That the City Clerk is hereby directed to publish a copy of this Ordinance in pamphlet form for a period of not less than ten (10) days, and to complete a Certificate of Posting consistent therewith.

Section 5: This Ordinance shall be effective from and following its passage, approval, and publication as required by law.
