AN ORDINANCE AMENDING CHAPTER 5.76 OF THE MUNDELEIN MUNICIPAL CODE TO DECREASE THE NUMBER OF CLASS B2 LIQUOR LICENSES AUTHORIZED IN THE VILLAGE OF MUNDELEIN AS IT RELATES TO MUNDELEIN OIL COMPANY DBA MARATHON GAS STATION LOCATED AT 1080 WEST MAPLE AVENUE

WHEREAS, on September 28, 2020, the Board of Trustees passed Ordinance No. 20-09-55 to the increase of the number of Class B2 liquor licenses authorized in the Village of Mundelein from zero (0) to one (1) in order to provide a Class B2 liquor license to Mundelein Oil Company DBA Marathon Gas Station located at 1080 West Maple Avenue; and

WHEREAS, the Board of Trustees has determined that it is in the best interests of the Village to decrease the number of authorized Class B2 liquor licenses from one (1) to zero (0) since the owner of Mundelein Oil Company DBA Marathon Gas Station, located at 1080 West Maple Avenue, sold the business prior to the issuance of the Class B2 liquor license.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF MUNDELEIN, LAKE COUNTY, ILLINOIS, that:

SECTION I. Subsection B.2. of Section 5.76.140, <u>License classification; fees; number; hours;</u> is hereby amended to decrease the number of authorized Class B2 liquor licenses from one (1) to zero (0), and shall henceforth read as follows:

- B.2. Class B2 license, (beer and wine package goods only at gas stations with convenience markets), which shall authorize the retail sale on the licensed premises of beer and wine and no other type of alcoholic liquor in their original packages, but not for consumption on the premises, where sold at a business operating a gas station with a convenience market in which greater than fifty percent of the gross sales of the business are derived from the sale of petroleum products, subject to the following conditions:
 - (1) The licensed premises include a building, in which a gas station with a convenience market business is operated, which building has not less than one thousand (1,000) gross, above grade, square feet.
 - (2) That portion of the premises devoted to beer and wine sales must be no larger than twenty (20) percent of the gross, above grade, square footage of the building in which the gas station with a convenience market is located.

(3) Beer shall not be sold in quantities of less than a four-pack.

(4) Wine shall not be sold in containers of less than three hundred seventy-five (375) ml.

(5) Each transaction for the sale of alcoholic liquor shall be with point-of-sale equipment that shall scan the identification of the customer as to verify age.

(6) The annual fee for each such license shall be one thousand five hundred dollars. There shall be no more than a total of zero Class B2 licenses outstanding and in force at any one time.

Sale of beer and wine shall be prohibited from twelve midnight through 6:00 a.m.

SECTION II. Severability. If any section, paragraph or provision of this Ordinance shall be held to be

invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or

provision shall not affect the remaining provisions of this Ordinance.

SECTION III. Repeal of Prior Ordinances. All prior Ordinances in conflict or inconsistent herewith are

hereby expressly repealed only to the extent of such conflict or inconsistency.

SECTION IV. Effective Date. This Ordinance shall be in full force and effect from and after its

passage, approval, and publication in pamphlet form, as required by law.
