

AN ORDINANCE AMENDING SECTION 2.36.150 OF THE MUNDELEIN MUNICIPAL CODE

WHEREAS, the Village of Mundelein, Lake County, Illinois, is a home rule municipality as contemplated under Article VII, Section 6, of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, the Village Board of Trustees has determined that it would be in the best interests of the Village of Mundelein and its residents to amend Section 2.36.150 of the Mundelein Municipal Code to modify its ambulance transport fee to reflect the actual transport cost; and

WHEREAS, the Village Board of Trustees hereby finds that it is reasonable, appropriate, and in the best interests of the Village of Mundelein to approve the fee provided for herein.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MUNDELEIN, COUNTY OF LAKE, STATE OF ILLINOIS, as follows:

SECTION I: Section 2.36.150, AMBULANCE TRANSPORT FEE SCHEDULE, subsection b, is hereby repealed in its entirety and replaced with the following:

(b) Ambulance Transport and Assistance Fee Schedule. The following ambulance transport and assistance fee schedule is hereby established:

(1) An Ambulance Transport Fee shall be charged for emergency medical services and ambulance transportation provided by the Village of Mundelein Fire Department.

(2) The fee charged by the Mundelein Fire Department shall be \$2,674.00.

(3) In addition to the Ambulance Transport Fee, the Mundelein Fire Department shall charge a mileage fee of \$15.00 per each mile a person is transported by an ambulance as reimbursement for the cost and expense of fuel and wear and tear on the vehicle.

(4) The Village shall charge a fee of three hundred dollars to a residential care facility for each occasion on which: (i) a residential care facility calls the Village of Mundelein Fire Department or ambulance service to the residential care facility to provide medical or assistive services to a resident of the residential care facility (whether or not such services are actually provided or accepted), and (ii) the resident is not transported by ambulance to a hospital or other facility.

(5) All fees due under this section shall be paid within thirty days after an invoice has been sent to the payer.

(6) The Village Administrator, or his designee, is hereby authorized to waive any or all fees due from a person, business, or other entity under this section pursuant to administrative regulation or on a case-by-cases basis. Individual consideration may be given where a person presents, in good faith, a financial hardship or inability to pay.

(7) All revenue from the charges assessed pursuant to the section shall be deposited in the general fund of the Village.

(8) Nothing in this section shall authorize the Mundelein Fire Department to refuse to provide any service to any person, business or entity that has not paid for services previously provided or that owes any money for services provided.

(9) As a function of accounts payable, the Mundelein Fire Department shall not pursue payment from Village residents beyond any portion of the ambulance transport fees paid by any private or public insurance source. Any such cost shall be full and final payment of all charges due to the Village from the person to whom services were rendered except for the deductible and coinsurance under benefits assigned.


SECTION II: Severability. If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such a judgement shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION III: All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION IV: Effective Date. This Ordinance shall be in full force and effect upon its passage, approval, and publication in pamphlet form (which publication is hereby authorized) as provided by law.


