ORDINANCE NO. O-25-02-5

AN ORDINANCE AMENDING CHAPTER 8.04.040 OF THE MUNDELEIN MUNICIPAL CODE, REGARDING PROHIBITED ANIMALS

WHEREAS, the Village of Mundelein, Lake County, Illinois, is a home rule municipality as contemplated under Article VII, Section 6, of the Constitution of the State of Illinois, and the passage of this Ordinance constitutes an exercise of the Village's home rule powers and functions as granted in the Constitution of the State of Illinois; and

WHEREAS, the Village Board of Trustees, on August 28, 2023 established through Ordinance No. 23-08-49 parameters for a limited number of residents to keep chickens; and

WHEREAS, the approved Chicken ordinance established a new chapter to the code under Animal Control, Section 8.08; and

WHEREAS, Chapter 8.04.040 section (f) of the Mundelein Municipal Code (Animal Control-General Requirements) was not updated at the time to remove chickens as a prohibited animal;

WHEREAS, it has been determined by the Mayor and Board of Trustees that it would be in the best interest of the Village and the public to amend the code language to specify the listed prohibited animals in Chapter 8.04.04 (f) are not allowed unless otherwise allowed via licensure within the same Chapter.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Mundelein, Lake County, Illinois, that:

SECTION I: The foregoing recitals shall be, and are hereby, incorporated herein by reference.

SECTION II: Section 8.04.040 (f) of Mundelein Municipal Code Animal Control; General Requirements currently reads:

(f) Keeping of Certain Animals Prohibited. No person shall keep within the village any horse, pony, cattle, cow, buffalo, sheep, goat, chicken, goose, duck, turkey, pigeon, and other livestock or swine, except for Vietnamese pigs.

SECTION III: Section 8.04.040 (f) of Mundelein Municipal Code Animal Control; General Requirements shall have the following additional language:

*(f) Keeping of Certain Animals Prohibited. **Unless otherwise permitted via licensure in accordance with this Chapter (Animal Control)**, no person shall keep within the village any horse, pony, cattle, cow, buffalo, sheep, goat, chicken, goose, duck, turkey, pigeon, and other livestock or swine, except for Vietnamese pigs.*

SECTION IV: In the event that any section, clause, provision, or part of this ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect. If any part of this ordinance is found to be invalid in anyone or more of its severable applications, all valid applications that are severable from the invalid applications shall remain in effect.

SECTION V: This Ordinance shall be in full force and effect from and after its passage, approval, and publication, as required by law.
