## **ORDINANCE NO. 18-04-20**

# AN ORDINANCE AMENDING CHAPTER 10.32, PARKING OF THE MUNDELEIN MUNICIPAL CODE REGARDING LONG-TERM PARKING AT THE COMMUTER RAIL STATION PARKING LOT

WHEREAS, the Village of Mundelein operates the commuter rail station parking lot adjacent to the Metra commuter rail station; and

WHEREAS, the President and Board of Trustees has determined that it would be in the best interest of Village to amend the regulations for long-term parking at the commuter rail station parking lot for the convenience of commuters;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MUNDELEIN, LAKE COUNTY, ILLINOIS, as follows:

Section I. Section 10.32.098(G), Commuter rail station parking lot, of the Municipal Code is hereby deleted in its entirety and the following included in place thereof:

- (i) Individuals who desire to park their vehicle in the parking lot for a period longer than a single day shall park their vehicles in spaces designated by a sign as "Long-Term Parking" spaces. Such vehicle owners shall be responsible for paying the daily parking fee for each weekday that their vehicle is parked in the parking lot. In accordance with Section 10.52.010 of the Municipal Code, no vehicle is permitted to remain in a parking space for a period longer than seven (7) consecutive days.
- (ii) In the event any vehicle owner requires an accommodation from the parking lot long-term parking regulations, prior authorization shall be obtained from the Mundelein Police Department.

Section II. This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law, but in no event shall this ordinance be effective prior to May 1, 2018.
