ORDINANCE NO. 4658

**Amending Division 2 of Title 5 of the Ordinance Code of San Joaquin  
County by Amending Chapter 2 Section 5-2202 and Chapter 4 Section 5-2404**

The Board of Supervisors of the County of San Joaquin (County) ordains as follows:

WHEREAS, Ordinance Code Title 5, Division 2, Chapter 15, Section 5-2983, allows the County to establish a fee paid by licensed collectors to offset County costs incurred to comply with SB 1383 requirements. Currently, the Department of Public Works (Public Works) has no funding mechanism to offset SB 1383-related expenses associated with licensed commercial and industrial waste collectors, which include, but are not limited to, administration, customer education, outreach, technical assistance, regulatory compliance, monitoring, reporting, and ensuring licensed collector compliance with applicable ordinance requirements.

WHEREAS, the Department of Public Works currently has no funding mechanism to offset SB 1383-related expenses associated with licensed commercial and industrial waste collectors, which include, but are not limited to, administration, customer education, outreach, technical assistance, regulatory compliance, monitoring, reporting, and ensuring licensed collector compliance with applicable ordinance requirements.

WHEREAS, SB 1383 changed the definition of residential waste generator from parcels with ten or less units to parcels with four or less units.

NOW THEREFORE, the Board of Supervisors of the County of San Joaquin ordains as follows:

Ordinance Code of San Joaquin County (Ordinance Code) Title 5, Division 2, Chapter 2, Section 5-2202, is amended in part to add the following:

***(I) A licensed collector shall pay a management fee to the County each quarter. The amount of the fee shall be equal to three percent (3%) of Gross Receipts for all services performed by the licensed collector. County shall use the fee to offset expenses, including but not limited to, administration; Customer education, outreach, and technical assistance; Regulatory compliance, monitoring, and reporting; and Contractor compliance with applicable ordinance requirements.***

Ordinance Code Title 5, Division 2, Chapter 4, Section 5-2404 (a), is amended to read in its entirety as follows:

***~~(a)The Board may establish mandatory residential solid waste collection areas by order of the Board. Unless otherwise specified by the Board, all unincorporated real property parcels, with at least one (1) and no more than ten (10) habitation~~***

~~units, for which any of the following residential zoning classifications apply, shall be included in mandatory residential solid waste collection areas:~~

***(a)The Board may establish mandatory residential solid waste collection areas by order of the Board. Unless otherwise specified by the Board, all unincorporated real property parcels, with at least one (1) and no more than four (4) habitation units, for which any of the following residential zoning classifications apply, shall be included in mandatory residential solid waste collection areas:***
