

**ORDINANCE NUMBER 1418**

***AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA ADOPTING INITIAL STUDY/NEGATIVE DECLARATION NO. 2372, MODIFYING PERRIS MUNICIPAL CODE CHAPTER 10.40 SO THAT THE TRUCK ROUTES DESCRIBED THEREIN ARE CONSISTENT WITH CONCURRENTLY ADOPTED AMENDMENTS TO THE PERRIS GENERAL PLAN CIRCULATION ELEMENT; MODIFYING CHAPTER 10.42, RELATING TO TRUCK ROUTES AND PARKING RESTRICTIONS ON COMMERCIAL AND OTHER VEHICLES, TO REMOVE THE PERMIT EXEMPTION FROM THE RESTRICTIONS AND PROHIBITIONS ON PARKING BY CERTAIN COMMERCIAL AND OTHER VEHICLES AS PROVIDED THEREIN; AND MAKING FINDINGS RELATED THERETO.***

***WHEREAS***, to preserve the health, safety, and welfare of the community, the City Council desires to establish and enforce designated Truck Routes and truck regulations that are consistent with the Perris Municipal Code and the General Plan Circulation Element, that reflect current land-use patterns and prevent truck traffic from traveling or parking on commercial or residential streets in the southern part of the City; and

***WHEREAS***, to achieve these goals, the City has introduced the following applications Ordinance Amendment (OA) 22-05069 amending Perris Municipal Code Chapter 10.40 – Truck Routes, including amending Perris Municipal Code Chapter 10.42 – Parking restrictions on commercial and other vehicles, and General Plan Amendment (GPA) 22-05068 amending the General Plan Circulation Element; and

***WHEREAS***, the proposed amendments are considered a "Project" as defined by the California Environmental Quality Act ("CEQA");

***WHEREAS***, Initial Study/Negative Declaration No. 2372 was prepared and made available for public review and comment during a state-mandated 20-day public review period between May 11, 2022, and May 31, 2022; and

***WHEREAS***, On April 28, 2022, the Riverside County Airport Land Use Commission considered and determined that the Project is "Consistent" with the 2014 March Air Reserve Base/Inland Port Airport Land Use Compatibility Plan and the 2011 Perris Valley Airport Land Use Compatibility Plan; and

***WHEREAS***, Section 1.04.070 of the City of Perris Municipal Code (Amendments to Code) authorizes the City to adopt ordinances that repeal, amend or add to any portion of the Code; and

**WHEREAS**, a Planning Commission duly noticed public hearing was held on June 1, 2022, at which time all interested persons were given full opportunity to be heard and to present evidence; and

**WHEREAS**, prior to taking action, the Planning Commission heard, been presented with, and reviewed all of the information and data which constitutes the administrative record for the approval as mentioned above, including all oral and written evidence presented to the City during all Project meetings and hearings; and

**WHEREAS**, on June 1, 2022, the Planning Commission considered Initial Study/Negative Declaration No. 2372, Ordinance Amendment (OA) 22-05069) and General Plan Amendment (GPA) 22-05068, and recommended to the City Council adoption thereof; and

**WHEREAS**, the June 14, 2022, City Council public hearing on the Initial Study/Negative Declaration No. 2372, Ordinance Amendment and General Plan Amendment, has been duly noticed; and

**WHEREAS**, prior to taking action, the City Council has heard, been presented with, and reviewed all of the information and data which constitutes the administrative record for the approval as mentioned above, including all oral and written evidence presented to the City during all Project meetings and hearings; and

**WHEREAS**, all other legal prerequisites to the adoption of this Ordinance have occurred.

***NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS DOES HEREBY ORDAIN AS FOLLOWS:***

**Section 1.**     Recitals Incorporated. The City Council of the City of Perris finds the above recitals are true and correct and incorporated herein by this reference.

**Section 2.**     CEQA. Based upon the forgoing, all oral and written testimony (including without limitation testimony by members of the public and City staff and the related staff report and exhibits/attachments presented at the public hearing), the City Council hereby determines that the potential environmental impacts of Ordinance Amendment 22-05069 were assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (“CEQA”), the State CEQA Guidelines (“CEQA Guidelines”), and the environmental regulations of the City in Initial Study and Draft Negative Declaration No. 2372 which analyzed the potential impacts of the proposed project and was circulated for twenty days. The Initial Study found that the Project does not have the potential to significantly impact the environment. The City Council hereby finds and determines that this general plan amendment does not have the potential to significantly impact the environment and, therefore, adopts the Initial Study/Negative Declaration No. 2372 for Ordinance Amendment 22-05069.

**Section 3.**     Amendment to PMC Section 10.40.020 – Truck Routes Designated. Perris Municipal Code Section 10.40.020 shall be amended in its entirety as follows (~~striketrough~~ represents deleted language while ***bold italics*** represents added language):

“The following streets and highways in the city are hereby designated truck traffic routes and shall be identified and posted with appropriate signs:

- (1) Interstate 215: from its northerly city limits to its southerly city limits.
- (2) Western Way: from its northerly city limits to Harley Knox Boulevard.
- (3) Harley Knox Boulevard: from Interstate 215 to Redlands Avenue.
- (4) Indian Avenue: from Northern City limits to Placentia Avenue.
- (5) Perris Boulevard: from its northerly city limit to Harley Knox Boulevard.
- (6) Redlands Avenue: from Harley Knox Boulevard to Rider Street.
- ~~(7) Evans Road: from its northerly city limits at the extension of Orange Street to its intersection with the extension of Nuevo Road.~~
- ~~(8 7)~~ Morgan Street: from Interstate 215 to Redlands Avenue.
- ~~(9 8)~~ Rider Street: from Interstate 215 to Perris Boulevard.
- ~~(10 9)~~ Placentia Avenue: from Interstate 215 to Perris Boulevard.
- ~~(11 10)~~ State Highway 74 (Fourth Street): from its westerly city limits to its easterly city limits.
- ~~(12 11)~~ Ellis Avenue: from its westerly city limits to its easterly city limits.
- ~~(13 12)~~ Goetz Road: ~~from its southerly city limits to its northerly terminus at Case Road.~~ ***From the San Jacinto River to Ellis Avenue.***
- ~~(14 13)~~ Case Road: ~~from Goetz Road to Perris Boulevard.~~ ***“G” Street to I-215 freeway (Bonnie Drive).***
- ~~(15 14)~~ Ethanac Road: ~~from its westerly city limits to its easterly city limits.~~ ***from Barnett Road to the easterly city limits.***

***Section 4.*** Perris Municipal Code Section 10.42.020. Perris Municipal Code Section 10.42.020 is hereby replaced in its entirety as follows :

- (a) The restrictions and prohibitions set forth in section 10.42.010(a) and (c) through (h) shall not apply in the following instances:
  - (1) During the first 24 hours during which a vehicle is mechanically disabled;

(2) During that period of time in which property is actually being unloaded from or loaded into a vehicle;

(3) During that period of time in which a vehicle is parked or left standing in connection with, and in aid of, ongoing performance of a service to or on a property located in the city block in which such vehicle is parked or left standing.

(b) The restrictions and prohibitions set forth in section 10.42.010(a) shall not apply to the parking or standing of a vehicle in a commercial or industrial zone for periods of two consecutive hours or less while the operator of such vehicle is taking a meal or rest break.

**Section 5.** Repeal of Perris Municipal Code Sections 10.42.030 and 10.42.040. Perris Municipal Code Sections 10.42.030 and 10.42.040 are hereby repealed in their entirety.

**Section 6.** Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remainder of this Ordinance. The City Council hereby declares that it would have adopted this Ordinance, and each and every section, subsection, subdivision, sentence, clause, phrase, or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases, or portions thereof be declared invalid or unconstitutional.

**Section 7.** The Mayor shall sign, and the City Clerk shall certify to the passage and adoption of this Ordinance.
