

**ORDINANCE NUMBER 1457**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, AMENDING CHAPTER 10.36 (SPEED LIMITS) OF TITLE 10 (VEHICLES AND TRAFFIC) OF THE PERRIS MUNICIPAL CODE RELATING TO ADJUSTMENTS TO THE SPEED LIMITS OF CERTAIN STREETS IN THE CITY OF PERRIS AND REPEALING ORDINANCE NO. 1411**

**WHEREAS**, Chapter 10.36 of Title 10 of the Perris Municipal Code (“PMC”) establishes speed limits for certain streets within the City of Perris (“City”) in order to most appropriately facilitate the orderly movement of traffic and which are reasonable and safe on the respective streets as specified therein; and

**WHEREAS**, Section 22357 of the California Vehicle Code (“CVC”) provides that whenever a local authority determines upon the basis of an Engineering and Traffic Survey (“E&TS”) that a speed greater than 25 miles per hour would facilitate the orderly movement of vehicular traffic and would be reasonable and safe upon any street other than a state highway otherwise subject to a prima facie limit of 25 miles per hour, the local authority may by ordinance determine and declare a prima facie speed limit of 30, 35, 40, 45, 50, 55, or 60 miles per hour or a maximum speed limit of 65 miles per hour, whichever is found most appropriate to facilitate the orderly movement of traffic and is reasonable and safe; and

**WHEREAS**, Section 22358 of the CVC provides that whenever a local authority determines upon the basis of an E&TS that the limit of 65 miles per hour is more than is reasonable or safe upon any portion of any street other than a state highway where the limit of 65 miles per hour is applicable, the local authority may by ordinance determine and declare a prima facie speed limit of 60, 55, 50, 45, 40, 35, 30, 25, 20, or 15 miles per hour, whichever is found most appropriate to facilitate the orderly movement of traffic and is reasonable and safe, which declared prima facie limit shall be effective when appropriate signs giving notice thereof are erected upon the street; and

**WHEREAS**, Section 627 of the CVC defines the E&TS requirements deemed necessary by the State; and

**WHEREAS**, Section 2B.13 of the California Manual on Uniform Traffic Control Devices (CA-MUTCD) provides guidelines for setting speed limits to ensure consistency with CVC requirements; and

**WHEREAS**, City staff has conducted an E&TS, entitled “2025 Engineering & Traffic Survey” dated March 19, 2025, which has been prepared in accordance with all applicable sections of the CVC and CA-MUTCD.

**NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA DOES HEREBY ORDAIN AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are all true and correct and are incorporated herein by this reference as findings of fact.

**Section 2. CEQA.** This Ordinance has been reviewed by the City Council with respect to applicability of the California Environmental Quality Act (“CEQA”), the State CEQA Guidelines (California Code of Regulations, Title 14, §§ 15000 *et seq.*, hereafter the “CEQA Guidelines”), and any applicable local CEQA policies and procedures and City has determined that this Ordinance is not a “project” for purposes of CEQA, as that term is defined by CEQA Guidelines Section 15378, because City has determined, in its discretion and based on substantial evidence, that this Ordinance concerns organizational or administrative activities and presents no potential for resulting in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment.

**Section 3. Code Amendment.** Section 10.36.020 (Same – 25 miles per hour adopted on certain streets) of Chapter 10.36 (Speed Limits) of Title 10 (Vehicles and Traffic) of the Perris Municipal Code is hereby repealed in its entirety and replaced with the following:

“Sec. 10.36.020 – Speed Limits on Certain City Streets

Pursuant to California Vehicle Code Division 11, Chapter 7, Article 1, after an Engineering & Traffic Survey was conducted, the City Council adopts the following prima facie speed limits on streets within the City limits:

**Section 4.** Repeal of Ordinance No. 1411. Ordinance No. 1411, including Sections 10.36.030, 10.36.040, 10.36.050, 10.36.060, 10.36.070, 10.36.071 and 10.36.072 of Chapter 10.36 of Title 10 of the Perris Municipal Code is hereby repealed in its entirety.

**Section 5.** Severability. If any subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance or any part thereof is for any reason held to be unconstitutional or otherwise unenforceable by a decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portion of this Ordinance or any part thereof. The City Council hereby declares that it would have adopted each subsection, subdivision, paragraph, sentence, clause, or phrase thereof, irrespective of the fact that any one or more subsection, subdivision, paragraph, sentence, clause, or phrase be declared unconstitutional or otherwise unenforceable.

**Section 6.** Effective Date. This Ordinance shall take effect on the thirtieth (30<sup>th</sup>) day after the day of its adoption.

**Section 7.** Certification. The Mayor shall sign this Ordinance, and the City Clerk shall certify the passage and adoption of this Ordinance and shall cause the same to be posted at the designated locations in the City of Perris and codified in the manner required by law.
