

**ORDINANCE NO. 1765**

**AN ORDINANCE OF THE CITY COUNCIL OF THE  
CITY OF SAN CLEMENTE, CALIFORNIA,  
AMENDING CHAPTER 1.04.070 OF THE MUNICIPAL  
CODE OF THE CITY OF SAN CLEMENTE,  
RELATING TO THE CIVIC CENTER LOCATED AT  
910 CALLE NEGOCIO, SAN CLEMENTE,  
CALIFORNIA 92673**

**WHEREAS**, City staff no longer occupies the building located at 100 Avenida Presidio,

**WHEREAS**, with City Administration permanently occupying the City owned property located at 910 Calle Negocio, this location shall hereby be designated as the Civic Center;

**WHEREAS**, this change requires an amendment to the San Clemente Municipal Code (SCMC); and

**NOW, THEREFORE**, the City Council of the City of San Clemente, California, hereby ordains as follows:

Section 1: Chapter 1.04.070 of the SCMC, relating to the designation of the Civic Center shall hereby be changed to 910 Calle Negocio.

Section 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase added by this Ordinance, or any part thereof, is for any reason held to be unconstitutional or invalid or ineffective by any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the remaining portions of this Ordinance or any part thereof. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more subsections, subdivisions, paragraphs, sentences, clauses or phrases are declared unconstitutional, invalid or ineffective.

Section 3. This Ordinance shall become effective on January 4, 2024.


Section 4. Upon this Ordinance becoming effective, all previous Ordinances and Resolutions that are inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 5. The City Clerk shall certify to the adoption of this ordinance and cause it, or a summary thereof, to be published once within fifteen (15) days of adoption in a newspaper of general circulation printed and published within the City of San Clemente, and shall post a certified copy of this ordinance, including the vote for and against the

same, in the Office of the City Clerk in accordance with California Government Code Section 36933.


