**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SHASTA LAKE APPROVING THE ANIMAL CONTROL FEE AND FINE SCHEDULE EFFECTIVE UPON ADOPTION AND IMPLEMENTATION OF ORDINANCE ORD-CC-2022-295 AMENDING TITLE 6 (ANIMALS) OF THE CITY OF SHASTA LAKE MUNICIPAL CODE**
